





Attached advised of arrest of New Left Extremist Abbie Hoffman on 8/28/73 in New York City (NYC) by NYCPD while attempting to sell three pounds of cocaine, worth \$500,000, to undercover police officers. Hoffman was arrested with three other individuals at the Hotel Diplomat, NYC, with all being charged with sale of dangerous drugs. Hoffman was also charged with possession of drug paraphernalia. Arraignment of Hoffman was set for 8/29/73.

Hoffman is co-founder of Youth International party (YIP), a loosely-knit antiestablishment, revolutionary youth organiztion formed in NYC in January, 1968. Hoffman has a long history of New Left violence and an extensive arrest record. Hoffman was a defendant in the "Chicago 2" Conspiracy Trial and, in 1972, authored "Steal This Book," a revolutionary manual complete with instructions concerning manufacture and use of explosives.

Subsequent information received from New York indicates that at 8/29/73 arraignment bail for Hoffman was set at \$200,000, and Hearing was set for 9/5/73 before special narcotics grand jury in New York.





CAVETT: What are you doing these days?

ABBIE HOFFMAN: Building a house with a group of friends, a collective; experimenting with new life styles; writing more - an article is coming out in Harpers re testing limits of free speech; doing research on a book; was busted on "set up" by the NYCPD - facing mandatory life. CAVETT said rules would not allow HOFFMAN to plead his case on TV but HOFFMAN stated he had no compulsion to not talk or write about it because they have all been on trial one way or another in the last 12 years.

JERRY RUBIN: Stated he was living in San Francisco, not married, and is getting in touch with himself and his body. He is living a quieter life but a evolutionary life.

RENNIE DAVIS: Talked about finding love and meaning of life through MAHARAJI JI, the 16-year old GURU. He is concerned with meditating and recently toured 22 states to spread teaching of GURU.

TOM HAYDEN: Works in a group based in Los Angeles, chapters in 25 states, called Indochina Peace Campaign. Purpose is to keep the issue of the current war in Cambodia before the people and to impress on Congress the need to cut aid for prolonging the war that goes on in South Vietnam and Cambodia.

CAVETT: Why aren't the old tactics being used now?

TOM HAYDEN: Replied that the situation today is different, the last time they were in congress together was when they were called before the HCUA, they had a confrontation with that committee which weakened the committee and because of them this committee changed its name; now he can teach a class with some congressional aids in a sub-committee room in the House of Representatives. The movement of the 1960's caused the election of people who they feel now represent the principles of peace and democracy. A by-product of the demonstrat of the 1960's and the Civil Rights Movement was a changed atmosphe in the country which permitted the election of desireable people. Certain things can now happen within congress, particularly cuttin off aid for Indochina.

CAVETT: Do they get any credit or do they think they were responsible for the end of the Vietnam War?

ABBIE HOFFMAN: Thinks they went to Chicago in 1968 to oppose the war in Vietnam and other reasons such as racism in the country, oppose policies of the people who were then in power. Replied that the people who opposed the war were responsible for ending the war. Stated the election of RICHARD NIXON was in the final analysis a good thing because now we are seeing the US Government in all its nakedness, corruption and brutality. Stated they were not aware of what was going to happen in Chicago. They went there to protest the policies of the US Government. Stated they were not a conspiracy then or now, that they were lucky to physically survive Chicago and lucky to survive all the Government threats to them.

JERRY RUBIN: We were in physical danger at all times but due to thrust of their actions he did not regret it. Thinks the 1960's were one of the greatest periods in American History - proud to be part of a generation that did what they did as everything they did has been proven correct - we did things in the 1960's which added to the demise of the government. I acted on my beliefs and am not interested in any credit - I acted because I was outraged about what my Government was doing in Vietnam and the quality of life in America.

CAVETT: How much did you plan what people might call your bizarre actions? Was there a game plan or philosophy of when or when notto to break the law?

ABBIE HOFFMAN: No, but there was a kind of spirit you might want to put forth which would encourage spontaneous outrage on the part of the people - we were not a carefully organized conspiracy, we were not the kind of movement that existed in the 30's of tightly organized groups; we were not based on carefully thought out plans or sterile ideological committment; our struggle was a struggle that grew out of moral outrage, it grew out of personal experiences which were witnessed and absorbed the ideas we had were not ideas that grew out of books, they were ideas that grew out of action and struggle. Some of the outrageous acts/done because we were fighting in a electronic jungle which allowed one minute to get across the message.

JERRY RUBIN: The struggle grew out of outrage but there was a strategybecause in the early 1960's we were a vocal minority and the media was uninterested in publishing the facts of war in Vietnam and we did plan activities that would get attention of the media to then influence and mobilize public opinion against the immoralities of the country.

CAVETT: Was it worth it?

JERRY RUBIN: None of us were worried at any time about breaking the lawbeause the law was immoral.

CAVETT: Was there any guilt for what you did or caused?

ABBIE HOFFMAN: Felt guilty for having to attack other people due to their differences of ideals, but not for any actions in the or against the Government.

CAVETT: How about the people in the movement who blew themselves up, any guil about them?

JERRY RUBIN: I don't feel any guilt because feeling guilty implies a lack of responsibility and I take responsibility for everything I did. The people in the movement took responsibility for their action. No body did what they did on orders from any hierarchy but acted because of their own personal motivations. There is a collective mass guilt in this country because citizens in this country do not take responsibility being evil in the way it oppresses black people, putting people in jail, and the war in Vietnam.

CAVETT: Was their action at the Chicago trial cooly calculated?

TOM HAYDEN: They were aware they were not in a normal situation, not a normal courtroom or Justice Department; referred to recently released FBI documents which set forth FBI program starting in 1968 for getting rid of the New Left Movement. They knew they were in the hands of an extra-legal operation that became Watergate. He stated 350 FBI agents worked on their indictment and 57 witnesses were called against them. Said we needed to go out and speak and mobilize the people and had to do it knowing we were going to be accused of illegal acts for doing just that.

JERRY RUBIN: Stated we were not the victims of the Chicago trial, we were privileged to be on trial and to be covered by TV. Stated that after the Chicago trial, people looked on the court system in the US with a lack of respect and authority. Stated America is committing serious crimes.

RENNIE DAVIS: We tried to say that the legal system in this country is not in tune with justice. Not everyone agreed with our policies or style, but we made people conscious of corruption of the system.

TOM HAYDEN: It is ironic that the same people who wanted to send us to jail are now in jail themselves and we are out on the streets. Justice is still Political. Politically our case has been made and the case of those who wanted to silence the movement becoming increasingly discredited.

CAVETT: Are there any courts you respected?

TOM HAYDEN: We didn't like the way the system of Justice functioned, we were in various courts and were sometimes able to win, but you can have a good verdict and still say that the system that dispenses the verdict is rotten.

CAVETT: What is going on today?

JERRY RUBIN: The 60's were issue oriented, in the 70's the people are going inward and discovering themselves. The movement is by no means dead. Society is in great crisis and the country is falling apart. There is a spiritual and cultural renaissance going on in this country.

CAVETT: What part do any of you plan to play?

JERRY RUBIN: The late 70's are going to combine the action tactics of the 60's with the intouch feelings of the 70's. The most important thing going on is the Women's Movement because that breaks down the whole structure of society. Women are discovering their power. There were women active in the Yippies but they didn't have a chance to express themselves because of male chauvinism in the movement and society. JUDY GUMBO and NANCY KURSHAN were women in the Yippies. The men dominated, however, and that is one of the reasons why the movement dissintergrated.

CAVETT: What do radicals live on when they are radicalizing and where do you get your income?

RENNIE DAVIS: Most of us get our money from people who support our work, but there is little of it and no life style attached to it. Generally get money out of speaking or contributions from people who support the kind of vision we strive to work for.

JERRY RUBIN: Commented he got money from stealing. The rich get their money from owing the natural resources of our world - the real question should be where the rich get their money.

ABBIE HOFFMAN: During and after the trial we got alot of money giving speeches, writing books; almost all the money was absorbed into the trial but the IRS did investigate, at least against me, and assessed me for money that was donated for the trial. The IRS was definitely used by the Nixon Administration to fight protest movement.

CAVETT: What if a kid gets hold of some of your old rheotoric and says Idm going to throw a bomb into a munitious plant, what would you tell him?

ABBIE HOFFMAN: Used "never met a man who was corrupted by a book or anything". The use of bombs at that particular mement will be the correct method - I think tactics of struggle are decided by the people who engage in struggle and if they're good the tactics will fit - hard to judge tactics - the act would have to be tied to some goal, why was the person doing it and everything.

TOM HAYDEN: I can understand the spirit of the person but I don't think it would be the most effective thing to do right now because what you really have to do is blow up what is in peoples heads that keeps them from seeing what is going on.

Following the appearance of HOFFMAN, RUBIN, DAVIS and HAYDEN, DICK CAVETT conducted an added hour discussion with JEFFREY ST. JOHN, political commentator and author, and FRAN GRIFFIN, Illinois State Chairman of the Young Americans for Freedom, who were designated as a "conservative" panel to comment on statements made by the "radicals" for the purpose of adding "balance" to the program.

During this "rebuttal" period, ST. JOHN and GRIFFIN did not refute individual statements made by the 4 radicals but pointed out that the 4 are really reactionaries who were "basically dishonest, morally corrupt, ruthless nihilists", that they didn't say "anything is justified if the cause is moral" but inferred that any tactics they could use were justified; that they didn't advocate violence, they just didn't denounce it, and allowed physical force to solve ST. JOHN characterized them as "4 little their problems. dictators looking for a dictorship", that they were very adapt at evading issues they wanted to evade; that they were not concerned with people and noted that the Left never supported efforts to abolish the draft because it was an issue with them to be used against the Government, which to them was more important. He stated they were 4 people committed to irrational behavior, that they believed the system of Government in the US wouldn't work and wanted us to change over to a Socialist system. He stated that TOM HAYDEN was interested in power, not an issues, but he did not consider him an intellectual. GRIFFIN noted that what is relevant is the damage the 4 did during the Vietnam war in that North Vietnam held out longer because of their actions. She stated that the 4 are all "has-beens" with the exception of HAYDEN who with his wife, JANE FONDA", are working for their cause which concerns POW3in Vietnam.

Although the various statements made by HOFFMAN, RUBIN, DAVIS and HAYDEN during the program indicated a hostile attitude towards the US Government, it is not felt that any of the statements are in violation of Federal law and no additional action is deemed necessary.

Reference is made to your memorandum dated March 19, 1974, requesting an electronic surveillance check on the above-captioned individual, and previous correspondence from this Bureau concerning Hoffman dated August 26, 1969, July 2, 1971, July 14, 1971, July 15, 1971, February 8, 1973, and April 2, 1974.

This is to advise that Bureau files contain no information relating to Hoffman not already set forth in the above-mentioned correspondence. In addition, our New York office reports that it has never disseminated any electronic surveillance data pertaining to Hoffman to the New York City Police Department, either in the present instance or in any other investigation.

It is suggested that other Federal investigative agencies be contacted to determine if they had coverage of Hoffman.



Abbie Hoffman was cofounder of Youth International Party (YIP) (a loosely-knit antiestablishment, revolutionary youth organization formed in New York City (NYC) in 1/68) and has an extensive history of New Left violence and related arrests. Hoffman was defendant in the "Chicago 7" Conspiracy Trial and in 1972 authored 'Steal This Book," a revolutionary manual complete with instructions concerning the manufacture and use of explosives. Hoffman was arrested 8/28/73 in NYC by NYCPD while attempting to sell three pounds of cocaine to undercover police officers. He was indicted on 9/5/73 and has been released on bond awaiting trial.

Attached notes New York State Supreme Court ordered forfeiture of Hoffman's \$10,000 bail and issued bench warrant for his arrest as result of his failure to appear in court, as scheduled, on 4/16/74. Inquiries in NYC indicate Hoffman reportedly isited his sister in Mexico City in 2/74, failed to attend his father's funeral on 3/29/74 and is not known to have been at hilong Island, New York, residence in the recent past. Hoffman's defense attorney is also reportedly unaware of Hoffman's whereabouts. New York attempting to locate Hoffman.



that he could furnish ho information concerning the whereabouts of the subject.

On April 18, 1974, Assistant District Attorney David Cunningham, NY County, NY, NY, advised that Hoffman reportedly had been residing at 14 East 11th Street, NY, NY, in the early part of 1974 but was no longer located at that address.

The subject's current whereabouts are unknown.

Arrests

1. Anti-Riot Law Violation, Chicago, Illinois

Hoffman was a defendant in the matter entitled United States of America vs. David T. Dellinger, Et Al," in United States District Court (USDC), Chicago, the trial commonly known as the Conspiracy Seven (Anti-Riot Law) trial, in the period September 24, 1969 to February 18, 1970. He was convicted of the substantive Anti-Riot Law violation for which tried, however, in January, 1973 that charge was dismissed at the request of the Government, when in November, 1972, the United States Court of Appeals (USCA), 7th Circuit, Chicago, reversed the conviction and remanded for a new trial, if the Government so desired.

On February 14, 1970, near the end of the above trial, Hoffman was cited by trial Judge Julius J. Hoffman for criminal contempt of court on 23 separate counts, as a result of his actions and statements in court during that trial. He was sentenced to a total of eight months in the custody of the Attorney General, bond was denied and on February 14, 1970, he was incarcerated in Cook County Jail, Chicago.

On February 28, 1970, the USCA, Chicago, issued an order for the release of Hoffman on bond, set in the amount of \$25,000.

On May 11, 1972, the USCA reversed the contempt convictions of Hoffman and remanded them to the USDC, Chicago, for a new trial before > judge other than the original trial judge.

On November 1, 1972, Assistant United States
Attorney (AUSA) Garry Starkman, Northern District of Illinois
(NDI), Chicago, advised that on October 30, 1972, United
States Supreme Court Chief Justice Warren Burger lad
announced the appointment of USDC Judge Edward T. Gignoux,
Postland, Maine, to rehear the contempt convictions of
Hoffman, and his fellow defendants from the Conspiracy
Sevan trial, likewise cited for contempt by Judge Hoffman.

Abbott Howard Hoffman

On November 29, 1972, AUSA Starkman advised the Government had determined that in the retrial proceeding involving Hoffman, sixteen of the original 23 contempt citations would be dropped, with only seven to be prosecuted.

On October 29, 1973, trial of Hoffman and his associates commenced in USDC, Chicago, on the contempt charges. On November 3, 1973, after defense arguments for directed verdicts of acquital on all counts, Judge Gignoux dismissed two of the seven remaining counts against Hoffman.

On December 4, 1973, at the conclusion of the bench trial, Judge Gignoux acquitted Hoffman on three of the five contempt counts and adjudged him guilty on the remaining two. He set December 6, 1973 for sentencing.

On December 6, 1973, Judge Gignoux discharged and released Hoffman, stating that in the present circumstances surrounding this retrial, he felt the guilty finding was sufficient punishment and that some four years after the original trial, no warrant existed for imposition of a jail sentence on Hoffman beyond the time already served by him (February 14, 1970 - February 28, 1970).

 Arrest by New York City Police Department August 28, 1973

advised that Abbie Hoffman and three others were arrested August 28, 1973 at Hotel Diplomat, New York City (NYC), by officers of the Narcotics Unit, NYCPD, while attempting to sell three pounds of cocaine, street value of \$500,000, to undercover agents of that department. That Hoffman was being charged for the sale of dangerous drugs and possession of drug paraphernalia.

Abbott Howard Hoffman

On September 5, 1973, a Special Narcotics Grand Jury, NY County, NY, NY, indicted Hoffman and three others on charges of possession and sale of cocaine. At the arraignment all were continued in \$50,000 bail and case was sent to the Narcotics Division of the Supreme Court of NY State, County of NY. On September 11, 1973, superseding indictments on Hoffman and three others added charges of conspiracy and of earlier sale of a small amount of cocaine.

On October 31, 1973, records of the Centralized
Special Parts, Supreme Court of NY State, NY County, reviewed
by Special Clerk
subject was released from the Manhattan House of Detention,
NYC, after cash bail of \$10,000 was posted September 14,
1973 by his wife Anita Hoffman Hoffman furnished address
as 640 Broadway, NYC, which is law office of his attorney,
Gerald Lefcourt.

On April 16, 1974, Special Narcotics Prosecutor Frank Rogers, NY County, NY, NY, announced that Acting New York State Supreme Court Justice Mary Johnson Lowe ordered forfeiture of subject's \$10,000 bail and issued a bench warrant for subject's arrest as a result of Hoffman's failure to appear for a NY State Supreme Court hearing on March 25, 1974. At that time, Hoffman's attorney, Gerald Lefcourt, requested and received delay of execution of warrant pending subject's next scheduled appearance in that court on April 16, 1974. Hoffman did not appear on April 16, 1974 and the bench warrant was put into affect.

Affiliation with the Youth International Party (YIP)

The YIP is a loosely-knit, antiestablishment, revolutionary youth organization formed in NYC in January, 1968. In May, 1972 a small faction calling itself YIP - Zippies came into being. About Howard Hoffman

Interview on "The Dick Cavett Show" March 21, 1974

On March 21, 1974, Tom Hayden, Jerry Rubin, and Rennie Davis appeared with subject as guests on "The Dick Cavett Show", ABC Television network, 11:30 P.m. - 1:00 a.m., Eastern Daylight Time. This program, originally scheduled to be presented February 7, 1974, was cancelled at that time and was reportedly presented on this date with minor alterations.

Tom Hayden, Jerry Rubin, and Rennie Davis, along with subject, on February 18, 1970 were found guilty in the so-called Conspiracy Seven trial of anti-riot law violations that arose from activities during the National Democratic Convention in 1968. On November 27, 1972, the United States Court of Appeals, 7th Circuit, Chicago, Illinois, reversed the conviction. On December 4, 1973, Hayden and Davis were acquitted of contempt citations arising from the trial while Rubin and Hoffman were found guilty of contempt but were discharged and released on December 6, 1973.

Abbett Howard Hoffman

In response to a question by Cavett, "What are you doing these days?", Hoffman replied; Building a house with a group of friends, a collective; experimenting with new life styles; writing more - an article is coming out in Harpers re testing limits of free speech; doing research on a book; was busind on "set up" by the NYCPD - facing mandatory life. Cavett said rules would not allow Hoffman to plead his case on TV but Hoffman stated he had no compulsion to not talk or write about it because they have all been on trial one way or another in the last 12 years.

In response to a question by Cavett, "Do they get any credit or do they think they were responsible for the end of the Vietnam War?", Hoffman replied: Thinks they went to Chicago in 1968 to oppose the war in Vietnam and other reasons such as racism in the country, oppose policies of the people who were then in power. Replied that the people who opposed the war were responsible for ending the war. Stated the election of Richard Nixon was in the final analysis a good thing because now we are seeing the United States Government in all its nakedness, corruption and brutality. Stated they were not aware of what was going to happen in Chicago. They went there to protest the policies of the United States Government. Stated they were not a conspiracy then or now, that they were lucky to physically survive Chicago and lucky to survive all the Government threats to them.

In response to a question by Cavett, "How much did you plan what people might call your bizarre actions? Was there a game plan or philosophy of when or when not to break the law?", Hoffman replied No, but there was a kind of spirit you might want to put forth which would encourage spontaneous outrage on the part of the people - we were not a carefully organized conspiracy, we were not the kind of movement that existed in the 30's of tightly organized groups; were not based on carefully thought out plans or sterile ideological commitment; our struggle was a struggle that

grew out of moral outrage, it grew out of personal experiences which were witnessed and absorbed; the ideas that grew out of action and struggle. Some of the outrageous acts were done because we were fighting in an electronic jungle which allowed one minute to get across the message.

In response to a question by Cavett, "What if a kid gets hold of some of your old rhetoric and says I'm going to throw a bomb into a munitious plant, what would you tell him?", Hoffman replied, using quotes, "never met a man who was corrupted by a book or anything". The use of bombs at that particular moment will be the correct method - I think tactics of struggle are decided by the people who engage in struggle and if they're good the tactics will fit - hard to judge tactics - the act would have to be tied to some goal, why was the person doing it and everything.
