A statement should be completed for equipment that currently exists in the telecommunications carrier's network that does not have the capacity to accommodate simultaneously the number of interceptions, pen registers, and trap and trace devices as set forth in the Final Notice of Capacity (63FR12217). This template is not limited to switches, but also other equipment, facilities, or services that provide a customer or subscriber with the ability to originate, terminate, or direct communications.

Recognizing that the Telecommunications Carrier Statement template is not mandatory, law enforcement encourages industry to use the attached template to facilitate submission of Telecommunications Carrier Statements. The information in the Carrier Statement will be used, in conjunction with law enforcement priorities and other factors, to determine the telecommunications equipment, facilities, and services that require immediate modification.

1.5 Telecommunications Carrier Statement Field Instructions

The following template fields are listed with a description of the information requested:

- (1) **Carrier** Enter the telecommunications carrier's name to identify ownership of this equipment.
- (1a) **Contact Name** The name of the person to contact should CIS have questions concerning the data provided in the Carrier Statement Template.
- (1b) **Contact Number** The ten (10) digit telephone number (npa-nxx-xxxx) for the contact person.
- (2) **Date** Enter the date (mm/dd/yy) that represents the effective date of the data provided.
- (3a) **CLLI Code** Enter the unique Common Language Location Identifier (CLLI) code or equivalent identifier for this equipment.
- (3b) **Equipment Type** Enter the current model of the equipment that specifies its type and manufacturer. This will allow for the determination of its general capabilities.
 - For example: AXE-10, 1AESS, 5ESS, DMS100, EWSD, GTD5, EMX2500, Autoplex 1000, DSC-STP, IBM-ISCP
- (3c) **City** Enter the City where this equipment is located.
- (3d) **State** Enter the State where this equipment is located.

WIRELINE ONLY:

(3e) **County(s)** - Enter the name of the county(s) that this equipment serves. (The term "County" includes buroughs and parishes, as well as the District of Columbia and a few independent cities in Missouri, Maryland, Nevada, and Virginia that are not part of any county. U.S. Territories such as American Samoa, Guam, the Phillipines, Puerto Rico, and the U.S. Virgin Islands are treated similarly.) This will allow for the proper correlation of the equipment to its appropriate serving area.

(3f) **Host CLLI Code** - If the equipment is a remote, enter the host CLLI code to properly identify the complete system that provides service.

WIRELESS ONLY:

(3g) **MSA, RSA, MTA, or BTA** - Enter the applicable Metropolitan Statistical Area, Rural Service Area, Major Trading Area, or Basic Trading Area number for the market(s) served by this equipment. This allows for the proper correlation of the equipment to its appropriate serving areas.
