A recent Public Service Commission order increased mileage charges and changed the administration and application of Cross Boundary Foreign Exchange (CBFX) service effective March 12, 1984.

Major changes to our present guidelines include the following:

- CBFX service will <u>not</u> be provided in exchanges between which there is Extended Area Service (EAS). Existing customers may keep present CBFX service until disconnected or changed.
- All new CBFX service will be provided on a one-party basis only, and existing two and four-party customers are grandparented.
- The two-mile limit to the Foreign Exchange Boundary formerly applied as a pre-requisite for CBFX service is removed.

Attachment I summarizes CBFX guidelines effective March 12, 1984 and cancels and supercedes previous guidelines issued February 9, 1983. Attachment II addresses some common questions related to Foreign Exchange Service.

The "CBFX-Unmet Requests Report" prepared monthly by sub-district is no longer required by Rates and Tariffs or Distribution Services Staff. This report can continue to be maintained by sub-district or can be discontinued.

Cross Boundary Foreign Exchange (CBFX) Guidelines

EXCHANGES BETWEEN WHICH THERE IS EXTENDED AREA SERVICE

- 1. CBFX will not be provided.
- 2. Existing customers may keep present CBFX service until disconnected or changed.

EXCHANGES BETWEEN WHICH THERE IS NO EXTENDED AREA SERVICE

- New facilities dedicated to CBFX service can be constructed as part
 of normal engineering, planning and construction activities required
 to service the exchange.
- 2. Construction charges based on current broad-gauge unit costs will continue to be applied when unusual costs are encountered.
- 3. Customers can order special construction so that CBFX service can be provided within a time period more suitable to their requirements. Special construction charges will then apply. The one route mile allowance for free construction does not apply when unusual costs are involved.
- 4. The two-mile limit to the Foreign Exchange Boundary formerly applied as a pre-requisite for CBFX service is <u>removed</u>.
- 5. All new service will be provided on a one-party basis only, and existing two and four-party customers are grandparented.
- 6. CBFX service will be allowed in adjacent exchanges only.
- 7. It is Company policy, that Interexchange Foreign Exchange (IXFX) facilities, i.e., trunk cables, will not be used to provide CBFX service.

Foreign Exchange Service Questions and Answers

- 1. Q. Why is CBFX service no longer available between exchanges offering EAS?
 - A. The original purpose of CBFX service (1951 Wisconsin Telephone Tariff) was to satisfy individual "community of interest" needs where customers were separated by exchange boundaries. The Public Service Commission ruled that EAS service satisfies reasonable community of interest needs and that CBFX service will no longer be available between exchanges offering EAS.
- 2. Q. Why is the two-mile limit formerly applied as a pre-requisite for CBFX service being removed?
 - A. The Public Service Commission ruled that although the two-mile limit was a reasonable attempt to provide cost effective CBFX provisioning, the decision to subscribe to the service should be non-discriminatory and the decision of the customer based on applicable rates and charges.
- 3. Q. What is the basic difference between CBFX and IXFX service?
 - A. CBFX and IXFX are both Foreign Exchange Services furnished from a central office of an exchange other than the exchange normally serving the area in which the customer is located. CBFX service is provided by an extension of the local loop network in the foreign exchange requested. IXFX is provided on an individual or PBX trunk basis. Rates and charges are based on components as shown in Exhibit A.
- 4. Q. What are the distinctions between Foreign Exchange Service (CBFX and IXFX) and Extended Area Service (EAS)?
 - A. Foreign Exchange Service and Extended Area Service are distinctively separate services. EAS is provided in exchanges to meet "community of interest" needs when a signficant number of customers are involved. CBFX service is an alternative on a reduced scale when EAS (elimination of long distance charges) cannot be justified.
- 5. Q. Did the Modified Final Judgment (MFJ), effective January 1, 1984, impact Foreign Exchange Service (CBFX and IXFX) and Extended Area Service (EAS)?
 - A. Yes. As of the effective date of the MFJ, Wisconsin Bell no longer provides <u>inter-LATA</u> service. Wisconsin Bell will no longer provide Foreign Exchange Service, neither CBFX nor IXFX, across a LATA boundary. However, EAS as determined by the MFJ is considered <u>intra-LATA</u> service. Therefore, facilities to provide EAS service may cross LATA boundaries.



- 6. Q. What section of the tariffs can be referred to for further information on Foreign Exchange Service?
 - A. P.S.C. of W. No. 1, Section 5.1.4, covers Foreign Exchange Service including the basis of offering, rates and charges, and construction charges. Note, the following are current as of 3-12-84 and are subject to change.

- 5.1.4 FOREIGN EXCHANGE (FK) SERVICE
- A. BASIS OF OFFERING
- 1. Foreign exchange service is exchange service furnished from a central office of an exchange other than the exchange normally serving the area in which the customer is located. It is not available in connection with public or semi-public telephone service.
- 2. Foreign exchange service from the Milwaukee Metroplan area is available only for the entire Metroplan area.
- 3. The scope of local service, the toll charges and the rules and regulations applicable to foreign exchange service are the same as apply in the foreign exchange for the service furnished. Foreign exchange service restricted to the serving exchange is not available from exchanges in the Milwaukee Metroplan area.
- 4. In the case of multi-office exchange or the Milwaukee Metroplan area, the central office from which foreign exchange service is furnished is determined by the Telephone Company on the basis of the facility conditions.
- 5. Foreign exchange service maybe furnished between two exchanges of the Wisconsin Telephone Company or between an exchange of the Wisconsin Telephone Company and an exchange of an independent company in the State of Wisconsin, when the independent company is willing to concurtant arrangements for furnishing such service. In those cases where a portion of the service is furnished by an independent company, the rates and regulations of the independent company apply to the part of the service it furnishes.
- 6. Optional calling service to the Milwaukee Metroplan area is not available with foreign exchange service over two miles from the foreign exchange boundary.
- 7. Foreign Exchange service is provided only for communications in which the customer has a direct interest and shall not be used for any purpose for which a payment or other compensation shall be received by him from any other person, firm or corporation for such use, or in the collection, transmission or delivery of any communication for others. This prohibition shall not apply to a customer who is engaged as a communications common carrier in a public telegram message business.

The rate for foreign exchange service is at the option of the customer the cross boundary or interexchange rate applicable in the foreign exchange for the class of service furnished, plus charges as shown in 5.1.4.B. following. Such services will be provided through facilities the Telephone Company deems the most economical. Service charges for connection, move and change and rates associated with basic exchange access lines are those charges and rates applicable in the exchange in which the customer is located.

In addition, the following mileage charges apply for each circuit.

- 1. For customers located across the boundary from the foreign exchange¹, the monthly rate for each basic exchange access line is the sum of a and b following:
- a. In customer's normal exchange: Between the customer's location and the nearest point on the Exchange Area boundary of the foreign exchange.

For Milwaukee exchange (normal exchange) customers, the mileage for FX service received from foreign exchanges will be measured between the rate center of the foreign exchange and the FX Rate Center at 68th Street and Aetna Court.

For customers of exchanges (normal exchanges) other than Milwaukee in the Milwaukee Metroplan Area, the mileage for FX service received from froeign exchanges will be measured between the Rate Centers of the respective exchanges.

The interexchange portion of multiple private line services and channels, including foreign exchange service, will be charged for as outlined in P.S.C. of W. No. 2.

b. Mileage is measured airline from the toll rate center to the customer's premises, **@n** excess of the following allowances.

Madison and Milwaukee - 2 miles All Other Exchanges - 1 mile

- (2) Station line service located in the normal exchange (Exchange in which the customer is located):
 - Foreign Exchange Service (Where basic exchange service line is located within 2 miles of the boundary of the foreign exchange) station line mileage will be measured in 1/4 miles airline from the location of the basic exchange service line to the location of the station line service and charged for at the rates shown in paragraph 5.1.4.B.(a) for individual lines.
 - Foreign Exchange Service (All other) mileage is measured and charged for as indicated for station line mileage in Section 10 of this tariff.

C. CONSTRUCTION CHARGES

Rates, Rules and Regulations governing construction charges as set forth in Section 4 of this tariff, apply to any construction necessary within the serving central office area. Such Rates, Rules, and Regulations also apply for construction necessary between the exchange area boundary of the serving central office and the foreign exchange customer's premises, except that the tane route mile allowance per customer does not apply to this construction.

5.1.5 FOREIGN CENTRAL OFFICE (FCO) SERVICE

A. DESCRIPTION

- Foreign central office service is exchange service furnished in a multi-office exchange from a central office other than that normally serving the area in which the customer is located.
- 2. Optional calling service to the Milwaukee Metroplan area is not available with foreign central office service.
