Nathan Alden Dykeman, date of birth December 15, 1980, home address 7973 West Plymouth Place, Littleton, Colorado, telephone number (303) 933-1708, was interviewed at the Regency Hotel, 3900 Elati, Denver, Colorado. Dykeman was advised of the identities of the interviewing Agents and was asked about his involvement with the April 20, 1999 shootings at Columbine High School (CHS) and his knowledge of where Eric Harris and Dlyan Klebold obtained the guns used in the shootings.

Present during the interview was Dykeman's stepfather, Victor Goode and Dykeman's mother Julie Goode. Dykeman provided the following information:

Dykeman stated he had no knowledge of, nor did he participate in, the planning or execution of the shootings at CHS on April 20, 1999. Dykeman stated he was at his residence at the above address at the time of the shootings and watched the events that unfolded at CHS from his house.

Dykeman was friends with the two identified shooters, Harris and Klebold and considered Klebold as one of his best friends. Dykeman stated that he did not have any idea that the events of April 20, 1999, at CHS were going to happen, nor that Harris and Klebold would perpetrate such an event. Dykeman stated that he had not associated that much with Harris or Klebold since early in 1999 when he began dating Christian Elizabeth Epling. When not at school, or at work, Dykeman spent all of his free time with Epling.

Dykeman stated he worked at the Blackjack Pizza, located at Ottawa and Pierce, Littleton, Colorado until April 1, 1999 along with Harris, Klebold, Christopher Morris, and Philip Duran. Dykeman recalled an incident in late January or early February 1999 when he observed Klebold hand Duran a large sum of money behind the Blackjack Pizza shop. Dykeman stated that he thought Klebold was buying drugs from Duran and began to harass Klebold about the exchange, as Dykeman is very much against drugs. Dykeman stated that after constant harassment about the money, Klebold told Dykeman that the money was not for drugs but that he, Klebold had purchased a gun or guns from Duran. Dykeman remembered the total amount of money was \$200 - \$300 and believed

that Duran sold Klebold a shotgun and pistol. Klebold never told Dykeman what he had planned on using the weapons at CHS on April

Dykeman described Duran as a white male, approximately 6 feet tall, a slim to medium build, dark hair and owner of a black Ford Taurus SHO, address unknown. Dykeman stated another Blackjack employee, Angel Last Name Unknown may be living at the same residence as Duran.

Dykeman stated he was willing to cooperate in this investigation and would volunteer further details about his knowledge of people that may or may not be involved in the shootings at CHS.

Nathan Dykeman, date of birth 12/15/80, returned a call to the interviewing agent and provided the following information:

Dykeman's attention was directed to the phrase "Chris, pizza guy's house". Dykeman believed that this might be a reference to their friend Chris Morris. He added that the new owner of Black Jack Pizza is Chris Last Name Unknown (LNU). Dykeman stated that Eric Harris had a lot of contact with Chris LNU. At first Harris did not get along with Chris LNU. Harris did not like the way Chris LNU was running the business while at the same time he was just sitting around in the back. The telephone number for Black Jack Pizza is (303) 978-0600.

He was also asked if he knew of an individual by the name of Yoshi. Dykeman explained that Yoshi had to be Yoshi Carrol. Yoshi is a friend of Dykeman's who came to Littleton, Colorado from Romania at approximately the same time that Dykeman came to Colorado in the 8th grade. Yoshi is a really nice guy who is involved in movies and the drama club. He is also a real smart math wizard. Dykeman did not know of any association between Yoshi and Dylan Klebold or Eric Harris. However, Klebold or Harris would not say anything derogatory about Yoshi in front of Dykeman because they both knew that Dykeman and Yoshi were friends. Andy Robinson is Yoshi's best friend.

Klebold never talked about napalm with Dykeman. Dykeman recalled that Harris would sometimes talk about how napalm was used over in Vietnam.

# ASSIGNMENT SYNOPSIS

An interview with Alyssa SECHLER on May 19, 1999, revealed that Nate DYKEMAN was in Denver from Florida to attend his girlfriend, Kristen EPLING'S High School Graduation. DYKEMAN was contacted on May 20, 1999 by Special Investigator Gary CLYMAN and agreed to meet with investigators on May 21, 1999

DYKEMAN was picked up, by his request, at EPLINGS residence by Special Agent Mark HOLSTLAW, of the FBI at approximately 08.00 a.m. and taken to the Jefferson County Court House. DYKEMAN was advised by CLYMAN that he was not under arrest, and could leave the follow-up interview any time he wanted. DYKEMAN agreed to answer questions and stated he understood he could leave. Dykeman sat in a chair near an unlocked door to the meeting room.

The following is a list of questions that were generated by reviewing all the investigative reports involving DYKEMAN to date

DYKEMAN stated the first time he saw KLEYBOLD or HARRIS with any weapons or explosives was approximately I year ago DYKEMAN stated he had seen KLEYBOLD make several small CO2 bombs He stated HARRIS and KLEYBOLD were always interested in things that exploded, and they just kept creating a larger bang. DYKEMAN stated he never thought HARRIS or KLEYBOLD were directing the explosives at anyone, he stated they just liked to blow things up.

> DYKEMAN stated several months ago he was at HARRIS'S home and Eric showed him a pipe bomb his parents had taken from him. HARRIS told DYKEMAN that his dad did not know what to do with it so his father placed it in his parent's closet. DYKEMAN stated HARRIS had additional pipe bombs he had made since the one was taken, and he kept them in his room DYKEMAN stated HARRIS had several CO2 bombs he had made sitting out in the open in his bedroom. He stated HARRIS showed him a hidden area in the basement window well of the HARRIS home DYKEMAN stated HARRIS just banged on the area to show him it was hollow, and he did not see inside HARRIS told DYKEMAN that he had to keep them hidden because he had just got into the diversion program. DYKEMAN stated HARRIS had a large roll of cannon fuse hanging on his bedroom wall. He stated he thought HARRIS got the fuse from OLD GLORY FIREWORKS in Denver DYKEMAN stated HARRIS had an explosive cookbook, and HARRIS also learned a lot about bombs on the Internet. DYKEMAN stated he never went shooting with them, however, he did see HARRIS and KLEYBOLD blow up a pipe behind Blackjack Pizza, and he saw them both blow up a bomb in a culvert near Wadsworth DYKEMAN stated he helped HARRIS depowder some fountain type fireworks approximately 8 months ago DYKEMAN stated HARRIS put the powder in a coffee can that was located in HARRIS'S bedroom DYKEMAN stated they did not build any weapons together DYKEMAN stated Chris MORRIS also knew about the explosives and weapons and was present when they tested them in the pipe behind the Blackjack Pizza.

DYKEMAN stated he a Chad Laughlin drove to Wyoming last year to pick up some fireworks. He stated he bought himself some Roman Candles, and KLEYBOLD gave him \$80 00 to pickup 9-gross of bottle rockets, and 6 mortars

- 2. The first time DYKEMAN ever saw them with any guns. besides a BB gun HARRIS had was when he confronted KLEYBOLD about seeing KLEYBOLD give Phil DURAN money behind the Blackjack Pizza store. He stated he thought KLEYBOLD was buying drugs and DYKEMAN stated he has no tolerance for drugs. When confronted by DYKEMAN, KLEYBOLD told him he was buying a shotgun from Phil DURAN DYKEMAN believed DURAN was a tag-a-long and the main gun supplier was Mark MANIS. DYKEMAN stated he saw the sawed-off shotgun KLEYBOLD purchased at KLEYBOLDS house. DYKEMAN thought the gun was purchased with the barrel shortened, because he saw it shortly after KLEYBOLD got it and he never saw KLRYBOLD cutting on it He stated he did not remember exactly when KLEYBOLD got the gun. DYKEMAN also saw a video of KLEYBOLD and HARRIS with 2 shotguns, a Tec-9mm, a rifle, and possible a pistol He stated he only saw the video, and was not there when it was made DYKEMAN stated HARRIS and KLEYBOLD were always making weird videos, but he thought it was just for fun. DYKEMAN looked down at the floor and stated he never realized they would hurt anyone.
- 3 DYKEMAN stated KLEYBOLD went to the prom in a Limo with several other couples. He stated KLEYBOLD was asked to the prom by Robin ANDERSON and had accepted ANDERSON liked KLEYBOLD a lot, however, KLEYBOLD just wanted to be her friend. DYKEMAN stated he was in the limo with MORRIS, MARKHAM, KLEYBOLD, EPLING, SECHLER, ANDERSON, and SECHLER'S boyfriend (name unknown). DYKEMAN stated HARRIS showed up at the after prom and was in a normal mood DYKEMAN stated KLEYBOLD and HARRIS left the after prom at approximately 2 30 a.m. He stated he did not know where they went. DYKEMAN did not remember seeing either of them again, or KLEYBOLDS date, ANDERSON. He stated MORRIS did not leave the after prom with HARRIS and KLEYBOLD because he remembered seeing MORRIS after the other two had left. DYKEMAN stated he and EPLING remained at the after prom until approximately 04 00 a.m., went to

- the mountains to watch the sun rise, and then returned to EPLING'S house.
- DYKEMAN stated HARRIS and KLEYBOLD were not in any of their classes on the day of the shooting. He stated the last time he saw either of them before he left the school was on May 19, 1999. DYKEMAN stated on the 19th he saw HARRIS and KLEYBOLD after 4th period and they both seemed normal. DYKEMAN stated he did not know of any "gathering" at the Outback Restaurant so he could not help with that. He stated if they went to dinner they did not invite him. DYKEMAN stated if there was a dinner MORRIS, MARKHAM, DURAN, HARRIS, KLEYBOLD, and ANDERSON might have been the people at it.
- 5 DYKEMAN stated he was at school on the day of the shooting, but left just before it actually started. He stated he always goes home for lunch and remembered leaving at approximately 11 20 a.m. He stated he does not eat lunch everyday with KLEYBOLD and HARRIS He stated he goes to his house and EPLING always goes to her house He stated he only has a couple of minutes to eat and he has to get back to school DYKEMAN stated he left through the west doors of the school and walked down the dirt path next to the school He stated he did not see anyone wearing a trench coat throughout the morning, nor did he see anyone outside the west doors DYKEMAN stated his car was parked near HARRIS and KLEYBOLDS vehicles, however, neither of their cars were there. He stated as he was driving out of the parking lot he saw HARRIS walking from the area of the junior parking lot, towards the south cafeteria doors He stated HARRIS was wearing a black trench coat and carrying a small black bag in his hand. He stated HARRIS had the small bag before in school and it had contained his CD Walkman and other regular possessions. He stated he did not speak to HARRIS, and that HARRIS was alone DYKEMAN stated he did no see KLEYBOLD.
- DYKEMAN stated when he was returning to school he came across a roadblock at Columbine and Pierce and again at Pierce and Walker. He stated the police had both intersections blocked and he couldn't figure out what was going on He stated it was approximately 11 40 a.m. and he saw school kids being routed out of the area.

DYKEMAN stated he saw Jen HARMON and he asked her what was going on HARMON stated 2 kids in trench coats were shooting up the school. DYKEMAN stated he did not want to believe it was HARRIS and KLEYBOLD but he thought it might be. He stated both of them had been acting strange for the last few months, but KLEYBOLD had been making future plans to move to Phoenix and attend school not to shoot up the school DYKEMAN stated he returned home and called KLEYBOLDS father He stated KLEYBOLDS father had no idea what as going on at the school KLEYBOLDS father told DYKEMAN something like "Oh My God" and he left the phone to see if Dylan's coat was in the house. DYKEMAN stated KLEBOLDS father returned to the phone and stated the coat was not there. DYKEMAN stated KLEYBOLDS father became extremely upset and DYKEMAN began to cry while talking to the Reporting Agent. DYKEMAN stated he could still not believe KLEYBOLD had something to do with the shooting and HARRIS must have "Had Something On Him" to cause him to participate He could not believe KLEYBOLD shot himself. DYKEMAN stated he could not believe KLEYBOLD could have kept this secret and DYKEMAN felt he should have done something to help KLEYBOLD

- 7 DYKEMAN was asked about his knowledge of Brooks BROWN, Chris MORRIS, and Robert PERRY He stated Chris MORRIS was probably HARRIS'S best friend, but he did not know if MORRIS knew about the shooting. He stated Brooks BROWN was never apart of the group and he is a compulsive liar DYKEMAN was asked if he had ever dyed his hair blond or knew anyone in school as tall as him with dyed blond, "Punk Hair" He stated he has never dyed his hair and the only kid that tall that has recently dyed his hair blond is Brooks BROWN He stated BROWN would change his hair often DYKEMAN stated know one he knows likes BROWN DYKEMAN stated Robert PERRY was a weird guy in school that none of the previously mentioned people hung out with. He stated PERRY was strange.
- 8 DYKEMAN was asked who "La VIDA X" was and he stated it was a screen name that he or KLEYBOLD may have used. He stated HARRIS had a nickname for everyone and DYKEMANS was "Devil Man"

  DYKEMAN stated he thought it was stupid and HARRIS

was the only one that used it DYKEMAN was asked if he had ever sent any threatening Email and he stated he was really mad at Devon ADAMS and may have sent her some bad Email. DYKEMAN could not remember what it said, but stated he was mad at her because she was saying things to get KLEYBOLD in trouble. ADAMS is Zack HECKLERS girlfriend. DYKEMAN stated he has never been on a "Rebel Mission", and stated he does not know what it is. He stated he thinks "NBK" stands for Natural Born Killers. He stated Natural Born Killers is a movie title of a film and it was one of HARRIS'S favorites.

- As a follow-up to an interview of Nate Dykeman conducted on May 21, 1999 (Lead no. 3862) by CBI
  Agent Jerry Means, and this investigator, I contacted Nate at his residence in Florida on June 3, 1999. He
  confirmed that he had in his possession two videotapes made by Dylan Klebold and him. One was made
  for the "Rebel News Network" announcements at CHS, and the other was made by them in 1998 for the
  purpose of showing Nate's father where he lives, goes to school, etc.
- Nate also had his 1998 CHS Yearbook, which contained the notes written to him by both Dylan Klebold and Eric Harris. Nate agreed to provide the videos to me, as well as copies of the yearbook notes.
- On June 9, 1999 I received the items from Dykeman by U.S. Mail. Copies of the yearbook notes are attached to this report. One video is a VHS format, titled on the spine "Dylan Klebold and Nathan Dykeman, Approx date Nov, Dec 98". The second video is in an 8mm format, titled "Intro RNN / Dylan, Nate".

4. I initialed each item with the date, and provided the originals to Inv/Battan. She copied the videos, booked the originals into evidence at JCSO, and will have me mail the video copies to Dykeman.

On the dates indicated, the following investigation was conducted by Special Agent MARK A. HOLSTLAW, Denver FBI, JTTF-DT:

On 02/23/2000, NATHAN A. DYKEMAN, DOB 12/15/1980, current residence at 3432 Pendleton Way, Land O' Lakes, Florida 34639, telephone 813-996-5088, was telephonically contacted and advised he was being requested to take a polygraph exam concerning his possible involvement in the COLUMBINE HIGH SCHOOL (CHS) shootings of April, 1999.

DYKEMAN advised he would discuss the matter with his father, MATT DYKEMAN, and get back to the FBI with an answer.

DYKEMAN also advised that on 01/20/2000, he had been in contact over the Internet with an individual using an E-mail address of "sara1061@yahoo.com." DYKEMAN's Internet service provider was JUNEAU. DYKEMAN later ascertained that this E-mail address belonged to a SARA HARRIS. HARRIS informed DYKEMAN she had previously talked with DYLAN KLEBOLD over the Internet prior to the CHS shootings. HARRIS informed DYKEMAN she would contact him later using a new E-mail address of "mycookeinurnooke@aol.com." DYKEMAN agreed to keep the FBI appraised of his conversations with HARRIS.

On 02/24/2000, MATT DYKEMAN telephonically contacted the FBI and expressed concerns about why his son was being requested to take another polygraph exam. After explaining to DYKEMAN why his son was being offered another polygraph, he agreed to talk the matter over with his son and get back with the FBI concerning his son's decision.

On 03/07/2000, NATHAN DYKEMAN was telephonically contacted and advised SA HOLSTLAW that since he already subjected himself to two polygraph examinations, he would not agree to a third one.

DYKEMAN advised that the first one, which he believed was fully-completed by the FBI; as well as a second one, which was provided by an ATF agent, revealed that he was telling the truth about his not being involved in the CHS incident. According to DYKEMAN, the ATF agent who provided him with a "visual polygraph," indicated to him that in the agent's opinion, DYKEMAN had been truthful and therefore, would not need to take another polygraph examination.

Epling and Sechler are both seniors at Columbine High School (CHS). Epling has known Dylan Klebold since kindergarten and Eric Harris since her freshman year. Klebold went to the prom with Christie Epling and her date, Nathan Dykeman, this past Saturday evening, 4/17/99. Klebold went with Robin Anderson to the prom and the after prom and seemed happy.

Epling had classes with Eric Harris and Dylan Klebold and saw them everyday at school. On 4/20/99 Epling and Sechler left CHS at the same time during their lunch hour at approximately 11:15 am. Both Epling and Sechler got in their separate vehicles and drove out of the CHS parking lot. While driving out of the parking lot they both saw Eric Harris driving into the school in his 2 door gray Honda Accord. Sechler honked her horn at Harris and waved and he waved back. Epling also waved at Harris. Epling proceeded to her home where she remained until she headed back to school at the end of the lunch hour. When she tried to go back to school the street was blocked off and Epling thought that there may have been an accident. A police officer told her that there was not going to be any more school because there had been a school shooting.

Epling explained that what the media was referring to as the Trench Coat Mafia was just a bunch of guys who hung out together. They were not a gang. She estimated that there were probably 8 - 10 kids who wore these trench coats. The kids whose names she could remember were Eric Harris, Dylan Klebold, Chris Morris, Tad Boles and Nathan Dykeman. Epling has hardly seen Dykeman wearing a trench coat. Dykeman has probably only worn a trench coat two or three times since January of 1999.

Nathan Dykeman and Dylan Klebold were best friends and like brothers. Dykeman and Eric Harris had previously had a fight over Epling as a result of Harris and Epling flirting with each other. Dykeman and Harris had resolved their differences and were friends again, although they were not as close as they used to be. Epling believed that Harris' closest friends were Dylan Klebold, Nate Dykeman and Chris Morris.

Epling expressed her disbelief that Harris and Klebold could have done what they did at CHS. She believed that Harris and Klebold kept to themselves. Nathan Dykeman is in shock over what has occurred. She believed that Harris was closer with Klebold, since Dykeman and Harris had their falling out.

Harris, Klebold, Morris and Dykeman worked at Black Jack Pizza, although Dykeman found a better job and his last day at Black Jack Pizza occurred about a week ago.

Harris did not get along with the "jocks" at school. The "jocks" made fun of Harris because of the way he dressed. wore black pants, black boots, a trench coat and a shirt bearing the name Rammstein. He also had a hat with the initials of some techno group. Harris had gym class before German class last year. Harris would tell Epling during German class that the jocks" pissed him off and they did not even know who he was.

Epling recalled that during their junior year Harris had stolen some computer parts from school and had been caught along with some other people.

Epling believed that Klebold had to be drawn into this by Harris on Sunday after the prom. Epling stated this because she recalled that Klebold was having so much fun at the prom.

Epling did not recognize the name Phil Duran. She had no idea where the weapons came from which were used by Harris and Klebold.

- 1. On May 20, 1999 Arapahoe S.O. Inv. Jackie Gee and I interviewed Kristen "Kristi" Epling (DOB: 02/20/81) at her residence, 5754 W. Leawood Dr., Littleton, CO (303) 795-8558. Also present were her parents, Robert C. Epling, Jr. (DOB: 01/14/53), and Ruth E. Epling (DOB: 6/07/53). Kristi has a younger brother, Nathan Epling, who was present in CHS at the time of the shooting, and ended up barricaded with other students and teacher Dave Sanders in the math/science area of the school. This follow-up interview was requested based upon recently developed information that on April 23, 1999, Kristi had sent notes made between her and Eric Harris to a friend in St. Louis, Lindsey Balsam, for safekeeping. The notes in question, which were undated, made reference to a "hit list" of Eric's. Kristi is also the girlfriend of Nate Dykeman, who was believed to have recently returned to Colorado from Florida, but according to Alyssa Seckler, he did not want that information known.
- 2. Kristi said that she will be graduating from CHS this coming Saturday, and will thereafter be studying marine biology at Eckert College in St. Petersburg, FL on an academic scholarship. She has been a friend with Nate Dykeman since January 1999, and they have been dating since late February 1999. The only class they had together this semester was a psychology class, although they saw each other daily outside of school. Nate is living with his father in Land O' Lakes, FL, and she last talked to him this morning when he called her from there.
- 3. Kristi has known Eric Harris since 9th grade, and characterized him as a good friend. She did not know Dylan Klebold well, and said that it appeared that those closest to him were Nate Dykeman and Eric Harris. Among the group of CHS students who associated with Harris and Klebold were Dykeman. Chris Morris, Tim Castle, and Chad Laughlin. All of them were together in the 5th hour psychology class of teacher T.J. Johnson (11:50 a.m.-12:40 p.m.) She attended A-lunch beginning at 11:10 a.m. She is out of school each day between 12:40-1:35 p.m., depending on whether she has to work as a student assistant in a biology class.
- 4. Kristi attended German class with Eric Harris last semester (4th hour), which they had each taken for four years. During class, the teacher ("fraii") allowed them to pass notes if they were written in German. Usually, they used one piece of paper for a class period, and the notes were generally thrown out, as they did not contain anything important. They typically talked about weekend plans, etc., and Eric would talk about girls he was interested in, and asking Kristi for advice.
- 5. In January 1999, she and Eric went on an informal date with several other friends, going midnight bowling at Belleview Lanes. Because Nate Dykeman was interested in her, this led to a falling out between Nate and Eric whereby the two of them did not speak for a while until she intervened and they made up. After that, Nate and Eric were not as close as they had previously been. Sometimes she and Alyssa Seckler would invite Eric to hang out with them, perhaps asking him to go get something to eat once every 2-3 months. This did not include Dylan, since she had only met him this semester.
- 6. Kristi said that Eric would often get angry when other students made fun of him, usually due to his small size, or the way he dressed in his long trenchcoat, black clothes, and T-shirts with German phrases. Eric would never react violently during these incidents, but would mention them later. She got the impression

that once he talked about it, these taunts would not really bother him anymore.

- 7. Kristi knew that Eric had been angry with two sophomores, Dan Lab, and his friend Brandon Larson, whom she referred to as "band geeks". Lab had apparently punched Eric in the face in 1998. She did not find out about this until November or December 1998, during which time she was dating Dan Lab. In talking with Eric around then, Eric mentioned the fight, and that he could not understand why she was dating Lab. Eric never talked to her about revenge against Lab.
- 8. Kristi began writing notes to Eric in class during fall 1998 through approximately early December 1998. The teacher then began letting them talk more in class, and the notes decreased. Others close to Eric in German class were Monica Schuster, Chris Walker, and Tiffany Typher (the latter mainly an in school friend only). Kristi said that in her opinion, Eric would have been capable of following through with a threat of retaliation against another student. She insisted that she saw no such threats in the notes he passed her, or that he verbalized, and if she had become aware of anything like that, she would have told a teacher. In retrospect, none of the notes she received from Eric had any significance regarding the events of April 20th Kristi said that as is usual, she cleans out all of her notebooks at the end of the semester, and she threw away any of Eric's notes. She has all of her notebooks at home, and did not have a locker at school this semester.
- 9. Regarding her day at school on April 20th, Kristi said she drove her VW bus to CHS with her brother, arriving at 7:30 a.m., parking in her space # 65 in the senior lot. She attended all of her classes, which in order from 1th 4th hour, were band, physics, AP English, (saw Nate briefly between classes), then German, which ended at 11:10 a.m. Since German was on the lower level of the school, she went through the cafeteria, exiting through one of the five side doors. She saw Alyssa Seckler outside the cafeteria, and they walked together to their cars, since Alyssa parks near her, and she was leaving to meet her boyfriend for lunch. Upon entering the lot, they got into their respective cars, and as she was driving out, (approximately 11.15 a.m.), she saw Eric Harris driving into the lot in his gray Honda, and he was alone. She honked and waved to him, and he waved back at her and smiled.
- 10. Kristi arrived at home at or about 11:20 a.m. When she left to return to CHS, she found that police at Leawood and Pierce blocked the street. She assumed there was a traffic accident, took a different route, finding everything near the school blocked. This is where she was told that there was a shooting at CHS, and she decided to go to Nate's house. She saw Nate at a nearby intersection, driving his old white Ford pickup. She followed him to his house. He told her then that there were apparently two gunmen in the school wearing black trenchcoats. Kristi said that when she heard this, she thought that it could have possibly been Eric and Dylan because they liked to wear the black trenchcoats. She had seen Nate wear his black trenchcoat once, and also saw Chris occasionally wear one, also. Even so, she would have been surprised if either of them would shoot anyone. She stayed at Nate's the remainder of the day, and also there were his mom and stepfather. A school friend, Jason Thompson, arrived at the house later, but left before she did.
- 11. Kristi said that Nate seemed "scared" of what was going on, saying "it can't be my friends" (doing the shooting). At or about noon, Nate called Dylan's house and spoke to his father, who apparently did not yet know of the shooting. Kristi called home around the same time to check on the status of her brother. At the request of her parents, she left Nate's house around 2:15 p.m. for Columbine Public Library, but did not locate her brother there. She then went home, and they eventually located him.
- 12. When asked if she had any idea who might help Eric and Dylan with planning or carrying out this attack at the school, Kristi said "none of my friends". She also said that prior to this she had never heard any discussion or rumors regarding April 20th. She had been aware from German class and German history that it was Hitler's birthday, but attached no other significance to the date.
- 13. When asked who would not be involved in this attack, she said "Chris Morris". She said that she was very surprised by what they did, because as recently as prom, Dylan had talked to Nate about future plans of attending a university.

- 14. When asked about what should happen to someone who did help with this attack, Kristi said "They should go to jail forever. It was a horrible thing". When asked what should happen to anyone who may have some information about the event or those involved, but have not provided it to investigators, she replied "I don't know, it would depend on what it was". She thought someone like that should probably get some help or counseling, but should get in some type of trouble depending upon their level of involvement.
- 15. We asked Kristi if there was anything she had not told us about concerning this incident, Eric, Dylan or anything else relevant, and she said there was nothing. She again reiterated that she had destroyed any notes of Eric's after finding a few of them in her room. When we gave her a few opportunities to disclose anything else, and that she would not be in trouble for doing so, she admitted that she had sent notes she had found to a friend in St. Louis, identified as Lindsay Balsam.
- 16. At this point, Inv. Gee had to leave for another appointment, and was walked outside by Kristi. When Kristi returned a few minutes later, she told me that she is supposed to let me know that Nate (Dykeman) is in town, and staying at the Epling house.
- 17. I then showed to Kristi a copy of the notes recovered from Lindsay Baisam, which she reviewed, along with a preceding e-mail message to Lindsay. She identified them as those items which she had mailed on April 23. She did not put a return address on the envelope because she does not usually do so. She met Lindsay last summer at Washington University in St. Louis, and they became good friends. She has sent Lindsay two e-mails since the April 20<sup>th</sup> shooting, and has received no response to either. She thinks the first was regarding the notes she was going to mail, and the next was regarding her going to Florida with Nate. Kristi said that when she found these notes from Eric, it was very painful for her to have them here because of her closer friendship with him. She did not want to destroy them, but thought that if she asked them to be kept for her far from here, she could someday retrieve them when the memory of what he had done was less clear. One of the items she had sent Lindsay was actually the page from her yearbook where Eric had written her a lengthy message, including a drawing, and a note to publish this statement if anything should ever happen to him. Kristi said that she did not send the notes to Lindsay in an effort to hide them from investigators.
- 18. Based upon the contents of the two pages of notes. Kristi believes that they were written between the two of them in German class at the end of November 1998, because they refer to her dating Dan (Lab), referred to by Eric also as "pretty boy". Kristi believes that of the two notes, the shortest was the first, because that is when she first found out from Eric that Dan had punched him the previous year. Regarding her use of the term "hit list" in the note, Kristi said that is a term that she had heard Eric use just very recently before this note was written. Eric used it meaning that anyone on the list was someone he did not like for some reason. She never actually saw a "hit list" of Eric's.

  The name "Terefered to in the note by Eric is someone unknown to her. In note number 2 (the lengthier note), her reference to being afraid you (Eric) will "kill him", are words that the bad used in talking to her concerning his fears about Eric. She said she never heard Eric threaten to kill for anyone else. Regarding Eric's written concern about anyone reporting these threats to the police, Kristi said that Eric's concern was that at the time, he was in the diversion program, and that such threats becoming known could negatively impact that. Beyond that, Eric did not seem to want to discuss with her the diversion program.
- 19. Regarding the Prom on the weekend prior to the shooting, Kristi said that she attended with Nate Dykeman, and they rented a limousine with several other couples. Those were identified as Dylan Klebold/Robyn Anderson (she described as in love with Dylan, he disinterested, she asked him to the prom), Jessica Hughes/Paul LNU (DU student), Janna Buchl/Brad LNU (DU student), Kelly Brown/Brandon LNU, Monica Schuster/Steven Partridge (CHS Jr.). Eric had asked Sabrina Cooley to attend, but unknown to him she had a boyfriend. She thought he had also asked someone from his video class (name unknown), but ultimately, Eric did not attend prom.
- 20. Kristi said that after prom, she went home and changed clothes, returning with Nate to the after-prom at CHS at about 1:15 a.m. When they arrived, she saw Dylan and Robyn (who had driven Dylan), Eric, and

Chris Morris. Nate went to hangout with the guys while she talked with Robyn. After a while, she and Alyssa Seckler went back through the maze which had been set up, and they saw Nate, Eric, Dylan and Chris already in the hallway playing games which had been set up there. This was at about 2 a.m., which is the last time she recalled seeing Eric and Dylan that morning. The school stopped letting people into afterprom at 2 a.m. Eric was wearing his blue flannel shirt with a black(?) T-shirt, and Dylan was probably wearing jeans and a dark shirt. Kristi recalled that there was only one door open leading into the interior of the school, which was in the main hallway, being the double doors near the gym hallway. Only one of the four doors was open, and there were a lot of adults in the vicinity. She and Nate left after-prom at about 4:30 a.m., walking out with Alyssa and her date, Derek. They left in separate cars, and went to breakfast at Denny's located at Hampden & Wadsworth. After breakfast, Nate drove her up Deer Creek Canyon, where they watched the sunrise. She was home by 7 a.m., and to church by 7:30 a.m.

- 21. Kristi said that neither Eric nor Dylan seemed different than usual at after-prom. She did not recall seeing either Dylan's or Eric's cars that evening. She had no information or theories regarding placement of any explosive devices within the school on prom night. She was only school friends with Robyn Anderson, not socializing with her. They were in the same German class together.
- 22. Kristi said that she had been to Eric's house on two occasions which she can recall, the most recent in January or February 1999. These were when she and Alyssa had gone by to ask Eric to go out with them, and were in his room for less than a minute. She cannot recall seeing anything unusual.
- 23. Kristi stated that Eric never expressed an interest to her regarding guns or pipebombs. Nate never talked to her about any such interests either. While at Nate's home on the afternoon of April 20, he told his parents that approximately one year ago, Eric had shown to him in his (Eric's) house, a pipe bomb. About one week later, Nate also told her that he had known about Robyn having purchased a shotgun for Eric. (This was after the information regarding Robyn Anderson had been made public). Kristi said there was no indication that Nate ever had any idea that Eric and Dylan had any intentions with the guns other than hunting. She was also told by Nate about 2-3 days after the shooting that he had once helped Eric depowder fireworks in Nate's garage, dumping the powder into a can. She does not know why this was done or what happened to the powder.
- 24. Kristi said that after April 20th, Nate got into a fight with his mother and stepfather, leading to him calling his father in Florida, and moving out there. Nate's mother allegedly took all of his CD's, trenchcoat, "White Zombie" flag, and other personal items, and gave them to various neighbors to hold for her. When Nate's father, Matt, arrived here, they moved into the Super 8 motel (Wadsworth and Hampden), from Thursday, April 22 Sunday, April 25. When they departed, Kristi went with them to get away from all of the media attention. She said Nate was planning on moving to Florida anyway to attend school for Microsoft training.
- 25. Kristi said that once she and Nate began dating, he spent very little time with Dylan and Eric, but rather spent all of his free time with her. Nate was working at a Firestone store from about 1 p.m.- 6 p.m., and then he would be with her. She has not heard of a birthday party or dinner attended by the friends of Eric and Dylan in early April. There were two evenings in late March when she was not with Nate, because she was in a school play She does not know what Nate did on those nights.
- 26. Kristi agreed to provide all of her e-mail screen names. She and her family all use a single PC at the home. Her father, Robert Epling, was agreeable to copying and providing all of Kristi's e-mail, but because of sensitive material related to his work, did not want to sign a consent to seize and search the family computer. Kristi provided the following screen names which she has used:

IO, Detective Jim Vonderohe, is a member of the Task Force that was formed to investigate this tragedy at Columbine High School and am assigned leads to follow up on regarding this investigation. The following supplement will be in reference to lead control #4621 which states that a Connie Cox, Tel. 303-795-0464, lives across the street from the residence of Kristi Epling whose address is 5754 W. Leawood Drive, Littleton, CO, Tel. 303-795-8558. The information in this lead was initially received on 04/22/99 which indicated that Connie Cox reported that her neighbor's daughter's boyfriend is a good friend of the suspects involved in the Columbine High School shootings/murders. Connie Cox stated that her daughter told her (Connie Cox) the other day that two weeks ago Kristen Epling and her boyfriend knew that Eric Harris was buying guns and that Eric Harris had his "hit list" on his computer.

IO received this lead control sheet on 06/17/99 and was aware of the fact that Kristen Epling was familiar with the two suspects in this investigation, Eric Harris and Dylan Klebold, based upon her association with her boyfriend, Nathaniel "Nate" Dykeman, who was also closely acquainted with the two suspects.

In researching this lead, IO determined that a complete follow-up investigation on this lead had already been conducted by Investigator Gary Clyman, a Columbine High School Task Force member, and an investigator with the State Attorney General's Office. Investigator Clyman's report, reference control #DN2075, and dated 05/24/99. indicates that he interviewed Kristen "Kristi" Epling, dob: 02/20/81, on 05/20/99 at her residence. Investigator Clyman's report further indicates that in paragraph #18 of his report Kristi Epling is questioned regarding her knowledge of the "hit lit" that Eric Harris kept on certain individuals. In reference to the issue of Nate Dykeman and her having knowledge that Eric Harris was buying guns, she was questioned about her knowledge of this by Investigator Clyman with the results reflected in paragraph #23 of his report.

Due to the fact that this lead has already been developed previously through another lead control number, IO concluded any investigation into this matter at this point.

Cory Friesen is an associate of the two homicide suspects, Eric Harris and Dylan Klebold, and was a member of the so called "Trench Coat Mafia" when he went to Columbine High School where he graduated from in 1997

This investigator asked Cory to describe the "Trench Coat Mafia" and his association with Harris and Klebold.

Cory Friesen stated the following:

That they were a group of friends who just did not fit in with the school community of "jocks" and others within the school.

That some students did intimidate the kids he knew in their group during the 1997-98 school year.

That in 1998 he began to dis-associate with the group

That both suspects used street names as follows:

- 1) ERIC HARRIS / "Reb" or "Rebel"
- 2) DYLAN KLEBOLD / "Vodka".

That both Eric and Dylan were inter-net junkies who spent hours on the "net"

That he believed they gained explosive device knowledge through the inter-net.

That he never thought "they" would go this far

That "Reb" had gotten into a WWII "Nazi" kick lately.

That he thought that Eric and Dylan were being picked on constantly at school, possibly in excess, and that they were never accepted by their peers at school.

That both boys were still in school as far as he knew and that they had been involved in some theft and petty stuff, but never any violence.

That both Eric and Dylan smoked marijuana and drank.

That the last time he saw either was on April 09, 1999 at Eric's birthday party at the Draft Bar & Grill at South West Plaza.

That at this party both Eric and Dylan were talking about the "Jocks" and said they wished that they (Jocks) were all dead.

That he thought that Eric and Dylan were joking and he just blew it off and did not take them seriously.

That when he heard about what was happening he tried to get to the school as his father is a teacher at Columbine, but went home when he could not get near the school

That a friend named Chris Morris was with him at the time and called into the Jefferson Co Sheriff's Office and told them that he knew who the suspects were.

That Morris is part of the Mafia group and knows the suspects very well

That Morris was the manager at the Black Jack Pizza store where Eric and Dylan also worked.

That Morris had told him of Eric's fascination with the Nazi thing

That Morris knew that Eric and Dylan could manufacture pipe bombs and had stated that Eric had a AK-47 or a shot-gun.

That Morris did not know where they got the guns, but he guessed illagally.

That Morris had possibly seen a recipe for explosives that Eric and Dylan had in their possession.

That Eric was infatuated with a girl at the school and really wanted her to like him, but she would not have anything to do with him

That Dylan did not have a girl-friend but had recently gone out with a girl named Kristen and supposedly had a good time.

That Eric and Dylan listened to "Dark Music" and "New Industrial" rock.

That he stated again that both suspects were heavily into computers.

Cory Friesen was interviewed extensively on 042499 by FBI SA Price and CBI SA Wilson. Cory was at the office of Chris Morris' attorney.

The bottle of Nitric Acid found between the houses was placed there by Eric Friesen, who is the chemistry teacher at Columbine High School. Eric placed the bottle of acid between the houses in late 1998 so the acid would evaporate. Disposal of the acid is controlled and this was a method of disposal. SA Bill Petoskey, FBI, verified that this was an accepted method of disposal for the acid. SA Petoskey is a chemist.

No further information was required. Lead was covered.

Cory Michael Friesen, date of birth April 3, 1979, home address, 5702 South Estes Way, Littleton, Colorado, home telephone number (303) 904-0818, was interviewed at the law offices of Richalano and Ridley PC, 1800 15th Street, Denver, Colorado. Friesen, who is not a client of John Richalano, was asked about his knowledge of the events that lead to the shooting at Columbine High School (CHS), on April 20, 1999.

Friesen, who is a 1997 graduate of CHS and who's father, Kenneth Friesen is a teacher at CHS, provided the following information:

Friesen stated that he had no knowledge of, nor did he participate in the planning or execution of the shootings and bomb placement at CHS on April 20, 1999.

Friesen is friends with Christopher Morris and through Morris became friends of Eric Harris and Dylan Klebold. Friesen stated that he was at one time part of the Trench Coat Mafia (TCM) and was in the 1998 CHS yearbook photograph of TCM members even though he had graduated from CHS in 1997. Friesen stated that neither Harris nor Klebold were part of TCM that he was aware of.

Friesen stated he had no knowledge of bomb making by Harris, Klebold, Morris, or anyone else. Friesen was aware that Harris and Klebold went shooting in the mountains, but was not aware of where the weapons came from.

The last time Friesen saw Harris or Klebold was at Harris' birthday party at the Draft Bar, located at the Southwest Plaza Shopping Center.

Friesen stated on the day of the CHS shooting, Morris was at his house playing computer games when Friesen's mother called and told them about the shootings and was wondering if Ken Friesen had come home or had called. Freisen additionally vouched for Morris' whereabouts the night before when they had gone to Video City, located at Jewell and Kipling, Lakewood, Colorado to see Friesen's friend Chuck Phillips. Freisen stated that they left Video City at approximately 10:00pm and returned

intervied Dustin Allen Gorton Dob/11-14-80 at his residence located at 5504 S. Eaton St. Littleton Colorado.

The reason for the interview was based on Information Control verification on DN1031. The information was that Dustin was originally interviewed by WILSON on the afternoon of 4-20-99 about the shooters in the incident at the high school and that he had assisted in the escape of numerous fellow students from the area of the cafeteria.

Furtheremore, Dustin had been implicated in a video filmed by ERIC JACKSON. Dustin and Dylan Kleybold (suspect) were in the video. During a lenghthy two hour interview Dustin stated that the video (taken monday am 4-19-99) was going to be used as set up video for the schools morning in-house television programs. The interview did not gleen any additional information as to any prior knowledge of the school incident or any information of knowledge that the suspects were going to attempt such an incident.

Dustin did state that when the incident began he was in the cafeteria near the center of the room next to an area that forms as a line to the food servers. (My estimation from seeing the bombs at their point of origin would be within a few feet of where Dustin and friends were having lunch.) Dustin stated that at his table were Greg Garcia / Richy Green / Shawn Roberts / Brett Kostalnick / Christian Garramone / Julie Anderson / Jason ? /Paul? / John Buttachi / and Dustin Gorton.

Kalinda Bingham and Nichelle Dunn were also in the immediate area around his table.

Although Dustin is or was friends with Eric Harris and Dylan Klebold he would not have allowed an incident of this type to occurr if he would have had prior knowledge. Dustin will call the interviewing Agents if any information is recieved or developed on his part.

Additional information regarding this interview will be supplied by FBI Agent Price as he took the notes on this interview.

Gorton was interviewed in the presence of his mother, Darlene, and his father, Don, at their residence. Gorton provided the following information:

Gorton was provided a diagram of the Columbine High School (CHS) cafeteria. A diagram was provided in order to show the location of where he and others were located in the CHS cafeteria on Tuesday, April 20, 1999. Gorton identified the location of where he was sitting as table QQ, facing directly west toward the windows. Gorton identified approximately ten other individuals sitting at table QQ with him. The others identified are as follows:

Brett Kostalnick, described as his back facing toward the west windows of the cafeteria; Richie Green, identified as facing to the northeast direction of the cafeteria; Greg Garcia facing to the south; Kristin Garamone; Paul (Last Name Unknown) (LNU) facing toward the southeast direction of the cafeteria, identified as being a 10th or 11th grader; Austin Mears, described as facing toward the north; John Bujaci (phonetic); Shawn Roberts; Julie Anderson, identified as sitting behind Dustin at table QQ; Brett Glassett, identified as a tenth grader facing in a north westerly direction. Gorton identified several others in close proximity to him as a Kalinda Bingham, Nichelle Dunn sitting with Kalinda, Chandra Marshal (identified as a band kid), Heather (LNU) (described as a friend of Heather's). Gorton identified Kalinda, Chandra and Nichelle sitting at either the tables identified as "R" or "W" tables. Gorton marked the locations of the individuals stated on the diagram. Gorton further provided his escape route once the shooting began and initialed and dated the diagram provided.

Question: Did you ever see the two large duffle bags in the

Cafeteria?

Response: No.

Ouestion: Did you see anyone carrying or was anyone in possession

of large duffle bags previous to the shooting incident?

Gorton, Harris and Klebold made a video tape at Eric Jackson's residence, another CHS student. Gorton identified the video session as being made on Monday morning (April 19) with Harris, Klebold, Jackson and

himself.

Ouestion: Did you leave anything behind in the cafeteria or any

where else in the school?

Response: Gorton left a leather bomber jacket, described as black

in color, left behind on the bathroom floor located

adjacent to the kitchen.

Gorton described papers as being left inside the pockets of the Wilson's X-large long, waist length jacket. Gorton described his left sleeve as having a blemish made from a fan belt of his vehicle. Gorton further described a video tape being left inside the

left breast pocket of the jacket.

Question: Who were you with in the cafeteria?

Response: (Individuals identified as) Brett Kostalnick, Richie

Green, Greg Garcia, Kristin Garamone, Paul (LNU), Austin Mears, John Bujaci, Shawn Roberts, Julie

Anderson.

Question: Where were you sitting?

Response: Table QQ, facing directly west toward the windows.

Question: Did you see or talk to any of the Trench Coat Mafia members on Monday, Tuesday, or the prior week?

Response: He saw Harris, Klebold and Chris Morris in bowling class that meets from 6:15 am to 7:20 am on Monday, April 19, 1999.

Gorton further stated he saw Nate Dykeman on Monday and Tuesday. Gorton further stated that he saw Dylan Klebold and Nate Dykeman at the Prom on Saturday prior to the incident. Gorton further stated he saw Kristie Epling during Prom and following the Prom.

Question: Have you heard anything from anybody else about other suspects, bomb making, gun buying, etc.?

Response: He heard from Robin Anderson on Friday, April 24th, 1999. He had heard from Kristie Epling that Robin Anderson had purchased a gun for Eric Harris on his birthday. He further heard that Kristie Epling was talking about Eric Harris' ammo bunker, and that she knows where Eric Harris maintained an ammo bunker described as being sort of in the basement, located in a crawl space. Gorton stated that Kristie Epling knows where that ammo bunker is located. Epling also told Gorton that Robin Anderson had turned herself in to law enforcement.

Question: What were you wearing?

Response: Gorton was wearing snow camouflage utility pants described as white, green, black, and brown colored camouflage utilities. Gorton further stated he was wearing a white colored T-shirt with the Rebel marching band insignia on the left breast of the T-shirt, a ball cap described as dark blue in color, with a Cleveland Indiansmajor league baseball team insignia on the front, and black Nrthwest Trritory hiking boots and a leather style bomber jacket.

Ouestion: Do you have a back pack?

Response: He does not use a back pack and that he stores his school belongings in his personally owned vehicle.

Ouestion: How did you leave the cafeteria or the building?

Response: He left through the exit door adjacent to the faculty

lounge located on the north side of the cafeteria.

Question: What were the events that made you leave?

Response: Law Enforcement SWAT teams were moving people out of

the building to a staging area.

Gorton stated that when the shooting began, he saw Dylan Klebold on the stairs coming down from the library. Gorton described that he had entered the cafeteria prior to 11:20 am as he had just left the Wood's Room. Following leaving the Wood's Room class, he exited the west doors, came down the stairs, located on the west side of the cafeteria, walked down and entered the cafeteria through the north west door adjacent to the faculty lounge. Gorton stated that he purchased a Mountain Dew soda and sat down at table QQ.

Gorton described hearing "Get Down" and hearing approximately eight (8) gun shots, described as small arms fire. Gorton further stated that he heard pipe bombs. Gorton stated that students began running at this time. Gorton further stated that he heard shooting of small arms gun fire, shotgun fire, and pipe bombs. Gorton stated he did identify Dylan Klebold. Gorton advised that he walked directly from the Wood Shop Room directly to the cafeteria. Gorton described his movement, once the shooting began, while he was sitting at table QQ, he and others got under the table and proceeded to move toward the kitchen area for safety. Gorton stated he ended up in the bathroom located adjacent to the kitchen area.

Question: Do you use the Internet?

Response: Yes he does and his screen name is "World Power".

Question: Do you have an ICQ?

Response: He recently started using ICQ and also used the screen

Gorton stated that he does not have an American on Line

Response: No.

Gorton did mention the name "Brandon Reisbeck", a CHS senior, an athlete and captain on the football team as

possibly having a double pierced eyebrow.

Question: Did you see or hear any unusual announcements prior to

the shootings?

Response: No.

Question: Do you know what the thought of the day was over the

Rebel News Network (RNN)?

Response: No.

Question: Can you provide any further information on the members

of the Trench Coat Mafia?

Response: I don't know.


Gorton stated that he saw Klebold with a weapon from the stairs. Gorton described the weapon that Klebold was carrying as a dark colored shotgun being carried in his right hand. Gorton further stated that once moved from table QQ, that he positioned himself behind the second serving window ducking down behind the serving line, that he saw Dylan Klebold coming down the stairs. Gorton described seeing Klebold just prior to the landing area of the stairway. Gorton stated he never did see Klebold fire his weapon or throw any explosive devices. Gorton stated he saw Klebold for approximately thirty seconds. Gorton

described his movements out of the cafeteria area as grabbing Brett Kostalnick and crawling to the bathroom area on the west side of the kitchen. Gorton described hearing two gunshot rounds and kids jumping as a result of the noise. Gorton further stated he heard one pipe bomb in the area where he was located. Gorton described the area of where he heard the explosion as being in the south west half of the cafeteria, (if he was guessing). Gorton described the bomb blasts as being five times as loud as the shotgun blasts. Gorton described other individuals being located in the bathroom with him as Julie Anderson, Brett Kostalnick, and several others that he was unable to identify at the time.

Gorton was cooperative during the interview and advised that he would be willing to take a polygraph examination if necessary.

## **PREDICATION**

Forensic polygraph psycho-physiological diagnostic techniques were used to determine whether the subject was being truthful or deceptive.

### **PROCEDURE**

The subject was examined on May 13, 1999 at approximately 0830 hours. Standard polygraph techniques were utilized for this evaluation.

Prior to the administration of the examination, the subject read and signed the Arvada Police Department Standard Polygraph Release form. The subject was advised of his rights, per Miranda, at 0833 hours. Subsequent to the advisement, the subject waived his rights and agreed to speak with this examiner. A pre-test interview was conducted during which time the subject stated his purpose for taking this polygraph examination was to "prove myself - that I had no prior knowledge or association with what happened three weeks ago," in reference to the murders at Columbine High School.

In discussing the issues involved regarding the murders at Columbine High School, the subject stated that he knew Eric Harris and Dylan Klebold and that he personally was upset that he got caught in the middle of this. The subject stated that on 04/20/99, he woke up that morning and realized he was supposed to be in first hour bowling class. He stated that he missed this class, which began at 0630 hours and, instead, went to his second hour class. The subject stated that Dylan Klebold was in his third hour class, which is a video class. The subject stated that they made a video the day before and were supposed to edit it on Tuesday, 04/20/99, but that Dylan Klebold was not in class that day. The subject further stated that Nate Dykemen told him that Dylan Klebold hadn't been to an earlier class that morning either.

The subject stated that he then went to his fourth hour class, which is a woods class that concluded at 1115 hours. The subject stated that he proceeded down the main hallway and outside the building and then through the west door of the commons. The subject stated that when he came outside, he saw Nate Dykemen leaving in his truck for lunch, which he normally does. The subject stated that he then went back through the west door of the Commons and went to his table in the cafeteria, where he met his friends who were eating lunch.

The subject continued by stating that approximately ten minutes into the lunch hour, they heard "popping sounds," which was similar to balloons being popped in the corner, which he now knows that these noises were made by shotgun blasts. The subject stated that a teacher came running across the Commons, yelling "get down, get down." The subject stated that he then heard two more shotgun blasts, so without thinking, he began throwing his friends under the table. The subject stated that as he was getting under the table, he heard six or seven rounds of small arms fire. The subject stated that he then heard another shotgun blast or pipe bomb explode. The subject added that all of these shots and explosions were made outside the Commons or cafeteria area.

The subject stated that his friends and he then crawled to the kitchen area, during which time they heard additional gunfire. The subject stated that they broke up into small pods, with him ending up in the bathroom, which is located off the kitchen area, along with six other people. The subject stated that they sat in there with the lights out and the doors blocked. The subject stated that they were in the bathroom for 75 minutes, during which time another student and himself crawled through the kitchen area. The subject stated that at this time, he observed a suspect dressed in dark colored clothing approximately 20 yards from him, with this person carrying a shotgun in his right hand. The subject stated that the other student and he went back to the bathroom and stayed there for awhile longer.

The subject stated that the group he was with then left the bathroom and went through the kitchen to a door that was next to a window. The subject stated that he looked out the window and saw law enforcement personnel outside the school building. The subject stated that he opened the door with the group, including himself, streaming out the door to the police officers waiting outside.

The subject stated that the last time he saw Eric Harris was on Monday morning, 04/19/99, in their bowling class. The subject further stated that he also saw him on that day when they passed each other in the school hallway.

The subject stated that he has known Eric Harris and Dylan Klebold during the four years of his high school education and was perhaps a little bit closer to Eric Harris than to Dylan Klebold. The subject stated that they were friends or school acquaintances, but that he never hung out with them after school. The subject further stated that he had never heard of the "Trench Coat Mafia" before this incident, but did know some of the students who were the long black trench coats.

The subject stated that he had no idea this incident was going to occur. The subject further stated that he did not know that Eric Harris owned a shotgun and went target practicing with it on weekends. The subject stated that he saw the shotgun in a video that they had made, with him describing it as a double barreled shotgun which really did not look real.

The subject further stated that he was never aware of either Eric Harris or Dylan Klebold ever making any threatening remarks or threats towards other students. The subject stated that he had no prior knowledge that this incident was going to take place on April 20, 1999. The subject further stated that he was surprised that Eric Harris and Dylan Klebold had semi-automatic weapons. There were no further statements made by this subject during the pre-test portion of the interview. The subject was then examined with an Axciton computerized polygraph system which is periodically calibrated to insure its accuracy and reliability. The instrument was correctly calibrated and was in proper working condition when this examination was conducted. Five polygraph charts were administered on the subject.

# RESULTS

Polygrams two, three, four and five contained the following relevant questions.

5. Regarding Columbine High School, did you personally participate in planning that armed attack?

Answer: "No."

7. On April 20, 1999, did you know for sure that armed attack would occur at Columbine High School?

Answer: "No."

10. Regarding Columbine High School, did you knowingly provide any of the weapons used in that armed attack?

Answer: "No."

The subject's psycho-physiological responses to the foregoing relevant questions were indicative of him answering the questions truthfully.

# DIAGNOSTIC OPINION

After careful analysis of this subject's polygrams, it is the opinion of the examiner that the subject has told substantially the truth.

Gorton previously reported to Agent Mark Wilson that he had previously provided information about the shooters in the CHS incident and that he assisted other CHS students from the main cafeteria to the kitchen area during the incident.

Gorton stated that he knows Eric Harris, Dylan Klebold, Nate Dykeman, Chris Morris, and Zachery Heckler and considers all of them friends. Gorton stated that he last saw Dylan Klebold on Monday, April 19, 1999. He stated he owns and drives a 1972 Chevrolet Chevelle described as green with a white hood and a white fender. He made a videotape of Harris and Klebold on Monday, April 19, 1999, described as a "looking video." Gorton stated that he and friend, Eric Jackson, filmed Harris and Klebold for the purpose of their "looking video assignment." He stated he is friends with associates of the Trench Coat Mafia. He stated the videotape taken on Monday, April 19, 1999, was going to be used as a set up video for the schools morning inhouse television program. Gorton did not provide any additional information as to having any prior knowledge of the school incident or any information or prior knowledge pertaining to the incident.

Gorton stated that he was in the CHS cafeteria described as being located near the center of the room next to the serving lines. Gorton sated he sat at a lunch table with Greg Garcia, Richy Green, Shawn Roberts, Brett Kostalnick, Kristen Garramone, Julie Anderson, Jason (Last Name Unknown) (LNU), Paul (LNU), and John Buttachi. He stated Kalinda Bingham and Nichelle Dunn were also in close proximity to where he was sitting. Gorton described that he heard what he believed was qunfire and pipe bombs while seated in the cafeteria. He described he heard thirty (30) rounds.

Gorton advised that he knew Eric Harris had guns and that he has seen Harris with a shotgun in a videotape. He stated he has set up targets in the forest for the purpose of Harris shooting. He named two other individuals he believed, besides Harris and Klebold, to be involved as Nathan Dykeman and Chris Morris.

He reiterated that he saw Dylan Klebold on April 19, 1999, during 3rd hour which begins at 9:30 AM. Gorton stated Klebold "seemed normal" and wanted to smoke. He described the videotape being made at Eric Jackson's residence and depicts Harris and Klebold "being late." During the video, Gorton, Jackson, Harris and Klebold proceed to the Burger King drive-thru located on Ottawa and Pierce, Littleton, Colorado, at approximately 9:50 AM. Gorton described that he is driving his 1972 Chevelle. Dylan Klebold is the passenger in the front seat and Eric Harris is a passenger in the back seat. The videotape depicts buying food and driving to the CHS student parking lot and having their breakfast in the parking lot. He described that following the videotape being made, the group entered the building at 10:05 AM proceeding to the Video Production Room, also known as (aka) the Tech Lab.

On April 20, 1999, he attended his band class for his first and second hour. Gorton stated Klebold was "not" in his 3rd hour Video Production Class from 9:25 AM to 10:10 AM on April 20, 1999. Gorton stated Dylan Klebold, Eric Harris and Chris Morris have a close relationship.

Gorton stated that he considered Eric Harris to be a good friend. He mentioned that he played "Doom" on his computer while residing at his prior residence located at 7819 West

Portland Avenue, Littleton, Colorado. He stated he attends a bowling class at the Fairview Lanes located on Federal Boulevard and Bellview which starts at 6:15 AM. Gorton stated 115 students attend the class. On Monday, April 19, 1999, Harris, whom attends stated bowling class, was seen shooting a CO2 powered pellet gun at the outside wall of the bowling alley.

Gorton provided names of individuals he considered to be part of the group known as the Trench Coat Mafia. The names provided are Nathan Dykeman, Zachery Heckler, Dylan Klebold, Eric Harris, Kristy Epling, Alisha (LNU) (described as a friend of Kristy's), and Chris Morris.

Gorton stated he did not notice anything out of the ordinary on April 20, 1999, when arriving or during school prior to the shooting. While seated in the cafeteria, he also noticed Kylinda Bingham and Nichelle Dunn. He stated, "Everybody has a back-pack" and did not notice any of the packs to be abnormal. He was shown a picture of a large nylon bag described as royal blue in color which he stated he did not see. He said if anyone would have known that the shooting incident was going to happen, it would have been the stated "they would of known."

In response to the question if he would be willing to take a polygraph examination, he replied he "would do." Gorton was cooperative during the interview.





He noted being contacted at approximately 1145 by a school mate, Robyn Anderson, and advised that she had been asked to accompany Eric Harris and Dylan Klebold to a gun show in December, 1998, at which time she had assisted them in purchasing 2 shotguns and a semi-automatic handgun. Anderson had advised him Klebold had purchased 1 shotgun and the other 2 weapons had been purchased by Harris. She was unable to provide him any other particulars about the weapons. She had told Heckler that she had confided in no one else regarding this information.

Calling his attention to his activities on 04-20-99, he noted arriving at school at 0730, parking his vehicle in it's assigned spot, just west of the cafeteria, and meeting Robyn Anderson in the parking lot. He commented that Klebold has the assigned spot next to him, however his car was not parked there as usual. He displayed into the school, first meeting Nate Dykeman who was sitting in his vehicle, a white full sized pickup, listening to 9 Inch Nails on his car stereo.

He describes the day as being normal until approximately 1120 at which time, while in the choir room, a school mate, Brandon Riesbach ran into the room and yelled, "someone's downstairs with a gun". The teacher, Mr. Andres, had made the students exit the room, and he accompanied others out the north door of the school, eventually arriving in Clements Park, where they stayed until contacted by police officers.

Heckler stated he generally talked to Klebold on the phone every night, and had called him the night of 4-19-99. He noted the first time he had called, Klebold had been talking to someone else on the other line, and had asked Heckler to call back later. He had made a call back at approximately 2230, at which time Klebold had said he was tired and was going to sleep. He thought this odd. He described their phone conversations as normal, usually about happenings, at school, and often times, about the computer game "Quake".

He went on the explain that his relationship with Harris had slacked off approximately 1 ½ years ago, when he (Heckler) had got into trouble at school for hacking into the school computer and obtaining locker combinations of other students. Harris had been involved in this incident, and as a result, his father had restricted them from being together.

Heckler noted being good friends with both Harris and Klebold since at least the 8<sup>th</sup> grade. He said they often did things together, and admitted that approximately 2 years ago, the had accompanied Harris and Kl. Uld as they drove around Harris's neighborhood and threw firecrackers in front of the houses of people Harris did not like. Heckler could not provided the identity of any of these neighbors, however

Heckler acknowledged being loosely associated with the Trench Coat Mafia, but explained that the moniker really meant nothing. He described the members as generally computer-type kids who spent time together, and often wore long black trench coats. He noted never wearing such an item of clothing himself. He explained that the "jocks" had thought up the name his sophomore year, and it had hung on since. He noted neither Harris or Klebold ever expressing any anger towards the "jocks" as a result of this. He did, however, say that both suspects were very racist.

Active member of the TCM were identified by Heckler as: 1. Tadd Bowles; 2. Nate Dykeman; 3. Chris Morris; 4. Joe Stair; 5. Robert Perry; 6. Brian Sargent; 7. Harris and 8. Klebold.

When asked to describe the suspects, he described Klebold as quiet, a Chemical Brother's fan, and a member of the sound crew for various school plays and other functions. Whereas Klebold had wanted to go to college and study computer science, Heckler did not think he was smart enough. He identified his girlfriend as Robyn Anderson, but described the relationship as more of a friendship. He stated Klebold had a problem with alcohol, and as a result had been given the nickname, "Vodka".

He described Harris as, in addition to begin a racist, feeling superior to other people, and being frustrated with oblems he was having at home. He said he had been told that Harris's parents were very strict and did not approve of many things he was doing. Heckler explained that during the past summer, Harris had changed his manner of dress and the type of music he listened to. Heckler identified the German group Rhomstein as being Harris's favorite. He also identified a video game, "Postal", as being a game Harris often played, and noted it involved nothing but killing. He said Harris did not have a steady girlfriend, and had asked Sabrina Cooley to attend the senior prom with him, but she had refused.

Heckler stated he regularly bowled with Harris and Klebold on Friday nights from 2330-0215 at Belleview Lanes, on South Federal. Monica Shuster and Robyn Anderson also bowled with them.

On 04-26-99, R/I was again contacted by Heckter and advised of additional information. He noted that he had heard "jocks" had been targeted, but he doubted this was true. He explained that the athletes generally sit at the same tables in the commons area of the cafeteria, and this is a well known fact. He explained that 4 security cameras are present in the cafeteria, and 1 is trained at this particular area. He surmised that if the athletes had been targeted, this particular area would have been singled out.

He also noted in his freshman year, he had been given the nickname "Kibble", because of his bringing snacks to school. He eventually modified this to "KIBBZ", which became his e mail password. He noted during this freshman year, that password had been used by other friends of his. He identified Harris as using the password "REB DOOMER". He noted on one occasion, Harris had asked him with assistance in setting up a web page from which various sound effects could be obtained. He noted that both Harris and Klehold made a number of videos. He also noted that an intro for RNN (Rebel News Network), showing a dar—jure in a trench coat igniting the letters "RNN", was made by Harris behind a Blackjack's Pizza at which they had all worked for a time

Heckler also alluded to one occasion where he had been told by Harris that his father had found a pipe bomb he had made, and he (Harris) and his father had gone out and ignited the device. Harris had explained his father had decided to ignite it following his determining he could not disarm it or bury it. Heckler estimated this as happening approximately 1 ½ years ago.

Heckler denies having any before hand knowledge of the incident.

Heckler consented to a search of his room, and recovered from his room were 2 CPU's, plus a number of CD-ROMS, re-writeable CD's and 31/2 " disks. 2 zip drives were also recovered from the residence. Heckler explained one of the drives contained items he had removed from his hard drive. The material removed included the anarchist cookbook. He explained he had removed this from his drive following the incident at CHS. These items were provided to CBI.

Heckler was interviewed in the presence of his father, Mark Heckler, and his mother, Veronica Heckler, at Zachery Heckler's residence. Heckler provided the following information:

Heckler was being interviewed based upon his alleged friendship with Eric Harris and Dylan Klebold, both identified as members of the Trenchcoat Mafia (TCM), and to his knowledge of the Columbine High School incident that occurred on April 20, 1999. Heckler had previously been interviewed by Special Agent (SA) Price, Investigator Mike Russell, and Sergeant John Hicks, on April 23, 1999. Heckler previously provided consent to seize two computer systems and a laptop computer from his residence.

cafeteria or anywhere on the grounds of the Columbine

High School?

Heckler further advised that he was in the Choir Room located on the upper level adjacent to the auditorium during the time the incident at Columbine High School



"UBJECT ZACHARY HECKLER

### **PREDICATION**

Forensic polygraph psycho-physiological diagnostic techniques were used to determine whether the subject was being truthful or deceptive.

# **PROCEDURE**

The subject was examined on June 16, 1999 at approximately 1456 hours. Standard polygraph techniques were utilized for this evaluation. Prior to the administration of the examination, the subject read and signed the Arvada Police Department Standard Polygraph Release form. The subject was advised of his rights per Miranda at 1457 hours. Subsequent to the advisement, the subject waived his rights and agreed to speak with this examiner.

A pre-test interview was conducted, during which time the subject stated his purpose for taking this polygraph examination was because he was requested to do this and that he hoped to clear his name of having any prior knowledge or assisting in that thing at Columbine High School.

In discussing with the subject regarding the issues surrounding the murders at Columbine High School, the subject stated that he recalled seeing Dylan Klebold the first day of their freshman year, but it was not until the second semester of that year that he had a class with Dylan Klebold. The subject stated that Eric Harris would come into the class from an adjoining classroom and talk to Dylan Klebold, during which time he was able to get to know Eric Harris also. The subject stated that between his sophomore and junior year, he worked during the summer at Blackjack Pizza. The subject stated that Eric Harris and Dylan Klebold also began working there during that summer. The subject stated that during that summer, he had met a girl identified as Devon and that the two of them spent a lot of time together. The subject stated that he went to Pennsylvania for two weeks during this summer and that during that time, Eric Harris and Dylan Klebold had built their first pipe bomb.

The subject stated that this past summer, 1998, Eric Harris really didn't like him for some unknown reason, but the subject stated that he was still good friends with Dylan Klebold. The subject stated that in February 1999, he attended a party at Robyn Anderson's home and that Eric Harris was also at this party. The subject stated that the two of them had both been at each other's throats for quite some time, but that at this party, Eric Harris approached him and asked him how he was doing. The subject stated that they then began talking about things and about their future plans. The subject stated that was the last time he talked to Eric Harris, except for passing each other in the hallways at school. The subject further stated that the last time he saw Eric Harris was at the "after prom," but that he did not talk to him at that time.

The subject stated that he saw Dylan Klebold at the prom, but did not talk to him very much during this activity. The subject stated that he then saw Dylan Klebold and Robyn Anderson at the after prom, but again, did not spend much time with him.

The subject stated that he did the "phone thing" with Dylan Klebold Sunday night, April 18, 1999. The subject stated that he would telephone him later at night and play "Quake" or just be on the speaker phones with him, during which time they really did not talk with each other.

The subject stated that he recalls passing Dylan Klebold in the hallway on Monday, April 19, 1999, and then Monday night, he telephoned him at approximately 2230 hours. The subject stated that Dylan Klebold told him when he telephoned him that he really wasn't in the mood to talk and just wanted to go to bed. The subject told Dylan Klebold that he would see him the next day. The subject further stated that he thought that this was kind of odd because Dylan Klebold normally doesn't get off the phone until 0030 hours to 0100 hours on most nights. The subject stated that this was the last time that he personally talked with Dylan Klebold.

The subject stated that on April 20, 1999, he went to school and was in the choir room when the shooting began. The subject stated that his sister, Joselyn, was in her math class during this same time period at 1115 hours. The subject stated that when the shooting began, he was able to escape from the building and did not see any of the suspects during his departure.

The subject stated that after leaving the school and during the afternoon of April 20th, he was at Clement Library, at which time it was mentioned that the shooters involved in this incident were members of the "Trench Coat Mafia." The subject stated that he immediately thought of Eric Harris as being one of the suspects and then thought of Dylan Klebold as being another suspect. The subject stated that if there was a third suspect, his thought was that of this person being

The subject advised this examiner that Dylan Klebold never mentioned anything to him about being involved in making bombs or any other explosive devices. The subject stated that Dylan Klebold did "slip" once, during which time he told the subject that he had gotten something that was "really cool." The subject stated that Dylan Klebold told him that this item was something that was in "Desperado," a Quinton Tarratino movie. The subject stated that in the back of his mind, the thing that he thought that Dylan Klebold was referring to was a gun. The subject stated that Dylan Klebold made this comment to him in February of 1999.

The subject further claimed that he played no part in planning or participating in any way in this attack on Columbine High School. The subject further stated that he did not have any knowledge that Dylan Klebold was making bombs or was target practicing with guns in the mountains.

During the latter portion of the pre-test interview, the subject admitted that there were two things that he had not mentioned in previous interviews with the police regarding this investigation. The subject stated that the first thing was that Eric Harris had come to him and expressed an interest in making napalm. The subject stated that Eric Harris wanted to know if the subject knew how to do it, with the subject responding that he did not know how napalm was made.

The subject further stated that the second thing that he had not previously mentioned was that he confronted Dylan Klebold about his suspicion regarding Dylan Klebold having some type of firearm. The subject stated that Dylan Klebold had told him that he had obtained a double barreled shotgun and that Eric Harris also had a shotgun. The subject stated that Dylan Klebold further advised him that the double barreled shotgun was like the one in the previously mentioned movie, "Desperado." The subject also added that Dylan Klebold told him that he had fired this weapon. The subject stated that this conversation with Dylan Klebold took place

in February of 1999. The subject stated that after being told this by Dylan Klebold, he never brought this issue up again with him. The subject stated that it just scares him that Dylan Klebold had all of this self control and yet he did not.

The subject elaborated on the above statements by stating that Eric Harris and he had left Robyn Anderson's party in March, at which time they drove in their own vehicles to King Soopers. The subject stated that after he had gone into King Soopers to buy a pop and a candy bar, and Eric Harris had gone into the store to buy a pop, the two of them met back at their cars, during which time they had a short conversation. The subject stated that besides buying a can of pop, Eric Harris also bought a box of bleach. The subject stated that he asked Eric Harris why he bought the bleach, with Eric Harris responding, "he was going to try it." The subject stated that was all Eric Harris said, so he (the subject) did not ask him anymore about it. The subject stated that he did ask Eric Harris what he was going to do with the box of bleach, with Eric Harris responding that he was going to try to make napalm with it. The subject stated that he did not say anything further about the purchase of the box of bleach.

The subject further stated that he has never mentioned having these conversations with Eric Harris and Dylan Klebold to anyone. The subject stated that is why, when it was announced that the "Trench Coat Mafia" members were the attackers in the school, he immediately thought of Dylan Klebold with a shotgun and Eric Harris trying to make napalm. The subject further stated that he had no prior knowledge about any of this catastrophe occurring at Columbine High School. The subject further stated that he also did not have any prior knowledge that either Eric Harris or Dylan Klebold had any explosives or other weapons, or that they were planning to commit this armed attack on the school. The subject further stated that he never asked Dylan Klebold if he sawed off the double barreled shotgun in order to make it very similar to the one that was used in the "Desperado" movie. The subject further stated that he does not think anyone else knew that Eric Harris and Dylan Klebold were planning to commit this armed attack on Columbine Highs School.

There were no further statements made by this subject during the pre-test portion of the interview. The subject was then examined with an Axciton computerized polygraph system, which is periodically calibrated to insure its accuracy and reliability. The instrument was correctly calibrated and was in proper working condition when this examination was conducted. Four polygraph charts were administered on the subject.

### RESULTS.

Polygrams two, three and four contained the following relevant questions:

4. Regarding Columbine High School, did you personally participate in planning that armed attack?

Answer: "No."

7 On April 20, 1999, did you know for sure that an armed attack would occur at Columbine High School?

Answer: "No "

8. Regarding Columbine High School, did you knowingly provide any of the weapons used in that armed attack?

Answer: "No."

The subject's psycho-physiological responses to the foregoing relevant questions were indicative of his answering the questions in an inconclusive manner.

# DIAGNOSTIC OPINION

After careful analysis of this subject's polygrams, it is the opinion of the examiner that the subject has answered the questions in an inconclusive manner and, therefore, no diagnostic opinion can be rendered.

ASSIGNMENT SYNOPSIS:

Eric JACKSON was interviewed at his home with both of his parents present. JACKSON stated his girlfriend; Krista HANLEY is a member of the TRENCH COAT MAFIA. He stated the TCM is a group of kids not a gang. He stated the media is making them sound like a bad gang of kids. He stated the schools jocks named the group the TRENCH COAT MAFIA and the group just accepted it. JACKSON stated he hangs out with the TCM but does not consider himself a member. He stated the members he knows are Eric HARRIS, Dylan KLEYBOLD, Chris MORRIS, Cory FREEZEN, and Zack HECKLER. JACKSON stated there is no leader of the TCM, however, KLEYBOLD was more dominant than HARRIS was. JACKSON stated HECKLER was good friends with both HARRIS and KLEYBOLD and he would know a lot about them.

JACKSON stated he and Dylan KLEYBOLD were good friends. He stated he saw KLEYBOLD on Monday at JACKSONS HOME. He stated they filmed a "BREAKFAST" video for Dylan's school project. The tape was called "American Dream". He stated Dylan was concerned about his grades. JACKSON stated the tape they made is located in his backpack in the choir room where he was when the shooting started. He gave the Reporting Agent a description of the backpack and gave permission to take the tape as evidence. The Reporting Agent located the backpack, lab personnel were notified of its evidence value, and they marked it for collection.

JACKSON stated he knew nothing about the shooting incident before it happened. He stated KLEYBOLD made a lot of racial remarks. He stated Eric HARRIS spoke fluent German. JACKSON stated HARRIS and KLEYBOLD both started wearing black in the 11<sup>th</sup> grade. He stated he never saw any of the TCM members with any weapons. He stated he does not own any weapons or have any knowledge of bomb making. He stated he has never seen any bomb making books.

JACKSON stated Alex MARSH, a female student told him "Do You Know Who I Say With A Gun, Dylan". JACKSON stated he and several other students ran through the auditorium and he could hear a lot of shooting.

Nicole Renee Markham, date of birth February 23, 1982, home address, 7156 Source Pierce Court, Littleton, Colorado, telephone number (303) 904-3538, was interviewed at the law offices of Richalano and Ridley PC, 1800 15th Street, Denver, Colorado. Markham was advised of the identity of the interviewing Agent and was asked about her knowledge of shootings at Columbine High School (CHS) on April 20, 1999 and the whereabouts of Christopher R. Morris during this time frame. Markham who was not represented by Morris' attorney, John Richalano volunteered to be interviewed.

Markham, who had been previously interviewed by an Agent from the Colorado Bureau of Investigation, provided the following information:

Markham is a junior at CHS and was in the school cafeteria at the time of the shootings on April 20, 1999. Markham stated she had no knowledge of the events leading up to the shooting at CHS nor did she participate in the planning or execution of the shootings at CHS on April 20, 1999. Markham did state that she is the girlfriend of Morris and was friends with the alleged shooters, Eric Harris and Dylan Klebold.

Markham has had a relationship with Morris since October 1997. Markham described Morris as having a bad temper at one time but no longer exhibits any hostile behavior. Markham believes that Morris had no knowledge of the shootings at CHS or he would have told her and her minth grade brother, Chris Markham, not to be in the school at the time of the shooting. Markham stated that when the shooting began she was in the cafeteria and heard her brother yelling for everyone to get down. Markham heard the shooting but she did not observe who was doing the shooting.

Markham stated she never saw or heard about any pipe bombs nor did she ever hear of any discussion about guns when she was around Harris and Klebold. Markham did recall coming into the CHS cafeteria in January or February 1999 and seeing Harris and Klebold holding a piece of paper which turned out to be a diagram of the cafeteria and the cameras in the cafeteria.

Markham stated she was friends with Harris and Klebold and even went to the Draft Bar, located at the Southwest Plaza Shopping Center, Littleton, Colorado for Harris' birthday. Markham was also aware that Harris and Klebold were at one time on diversion for stealing equipment out of a truck. Markham

still finds it hard to believe that Harris and Klebold could allegedly perpetrate such a crime.

Markham recalled that the only thing suspicious about Harris and Klebold was on the Monday before the shooting, both Harris and Klebold were in the CHS student parking lot after school about 2:30pm - 2:40pm. Markham thought this was strange , as neither Harris nor Klebold ever stayed after school for anything.

Markham stated that Saturday, April 17, 1999 she attended the CHS prom with Morris. They were accompanied by Meg Hanes and George Schwinner. Markham recalled seeing both Harris and Klebold at the After Prom at CHS. The last time she recalled seeing either Harris or Klebold was approximately 3:00 - 3:30am when Harris and Klebold said they were leaving. Markham recalled she and Morris left After Prom at approximately 5:00am, went to King Scopers for donuts and then returned to her parents house where they went to bed.

Markham stated that she would provide any information she could in furtherance of this investigation.

On April 21, 1999 at 1405 hours Agent HOLLOWAY and Agent Jerry MEANS of the CBI interviewed Alexandria MARSH. Sgt. Christen TOMFORD had assigned us to interview this witness prior to Rapid Start being set up to assist in tracking leads and interviews.

Alexandria was at her residence with her mother, Carmen MARSH, and other siblings. She stated that she was in the Commons Area (cafeteria) at the time she realized what was happening. Her first alert was when she saw Dylan KLEBOLD with a shotgun walking outside the cafeteria windows. Alexandria was assigned the first lunch period which began at 11:15 a.m. She had just arrived and was sitting at a table with Nicole MARKAM and Krista HANLEY. MARKAM and HANLEY had just left the table to get in the lunch line when she saw Dylan KLEBOLD waik past the window where she was seated. She was certain that the time would have been between 11:15 and 11:20 a.m. It was later learned that she and the other two girls were at table DD, which was very close to tables PP and QQ where the bombs were later located. Personal property from all three girl was recovered from table DD after the incident.

She was asked to describe what Dylan KLEBOLD was wearing and doing when she first notices him. She stated that he was dressed in his "duster" and jeans. She is talter that Eric HARRIS (a.k.a. REB). She first say KLEBOLD walk up the hill outside the window and then back down the hill carrying a canister in his hand. She then saw KLEBOLD though the canister into the senior's parking lot. She was fairly certain that the time was 11.20 a.m. when that occurred.. She never mentioned seeing Eric HARRIS that morning.

Alexandria MARSH then got up from her seat and went across the cafeteria to the bathroom area. A person she referred to as the young Mr. Lee ANDRES opened the door to the auditorium and told Alexandria (Alex) and approximately 20 other children to get into the auditorium.

She then went through the hallway and outside.

Alexandria MARSH stated that she was a past member of the Trench Coat Mafia. Last year she was involved with the "gang" and she still socializes with several of the kids involved with the "gang". She characterized the gang as wearing trench coats, using drugs and having short tempers that lead them into getting into fights. They were often brought in and questioned whenever something happened. They had been brought in for questioning and accused of drinking in the parking lot last year.

Alex MARSH related that members of the "gang" had talked about "blowing up the school" in the past, however, she was under the impression that none of them were serious about the threat. When asked what was said about blowing us the school, she related that it was mentioned that some "would get guns and meet and blow up the school." When asked who else was involved in the gang beside Eric HARRIS and Dylan KLEBOLD, she gave the names of:

Chris MORRIS - he frequently "hung out" with KLEBOLD and HARRIS. Described as being very involved with the gang.

Nicole MARKAM - home number (303) 904-3538. - Described as being very involved with the gang

Christine THEIBALT - she thought she may have been dating Dylan KLEBOLD.

Joe STAIR - graduated last year from Columbia High School. He would wear a duster. She did not see him at the school on the day of the incident. The last time she saw him was in September 1998.

Krista HANLEY Eric Jackson – dating Krista HANLEY

Alex MARSH further related that Dylan and "REB" (Eric HARRIS) had access to guns. She knew that the two had made bombs and had blown things up in a field.

She further related that was very proficient in computers. He is a senior and may have known about the plan before. She did not know if the two suspects used the Internet or had their own web page. She has not access to the Internet

Alex MARSH stated that both KLEBOLD and HARRIS were capable of doing what they did. They were very smart and felt very alienated. They would listen to hard rock and acid rock. She felt that the gang was forced "into a little box" by the rest of the school and labeled. "They" wanted this to be the bloodiest and gorious that it could possibly be. They wanted to kill as many as they could. They might spare someone that liked or recognized. "They" were aware that the "cops" used profiling and they would used motion sensitive devices to blow up the "cops". She denied that the gang believed in the white supremacy movement or were neo-nazi.

The interview ended at 1700 hours (5:00 p.m.)

On 05-05-99 at 1030 hours I interviewed Alex Marsh with her father present at her home. Alex stated she got a ride to Jason Duff's home from her mom the moming of 04-20-99. Jason lives near the school and they walked from Jason's home to the school arriving at approximately 0725 hours. They entered through the main entrance and Alex went directly to her locker on the upper level. She then went by the library and downstairs, straight to her Spanish class. She stated she did not see anything unusual outside the building or inside in between classes.

Alex stated she knew who KLEBOLD and HARRIS were. She stated she had worked with KLEBOLD on the fall play of Frankenstein that the school put on. She stated she knew him by his first name but he probably didn't know her by her first name. She stated she knew them mostly because her friends hung out with KLEBOLD and HARRIS. I asked her who those friends were and she told me Nicole Markham, Chris Morris, and Krista Hanley. She stated she knew who HARRIS was but recognized him more by his nick name of "Reb". She stated she didn't hang out with them. She stated she usually saw the both of them between her second and third period class. She stated they would be together and enter the building near the library entrance and walked down the hall. She stated she was not sure if she saw them on the day of the shooting. I asked her about the "trench coat mafia" group. She stated she was a part of the group, however the group was now dead. She stated the group

died when people stopped wearing the long, black trench coats. She stated that the group was more active last year. Many of the group's members were seniors and had graduated and left last year. Alex said that she did not have a long, black trench coat.

asked Alex for other members of the group. She stated Joe Stair was a member, as was Brian Sergeant. She stated that the group started to not like Brian Sergeant because he was beginning to be an "all around jack ass". She stated Eric Jackson was a member and provided most of the transportation for the group. She stated Kristen Theilbault, Tad Boles, and Charles Philips (graduated two years ago) were members. She stated she was closest to Nicole and Kristen and they ate lunch together every day. She stated she had advanced acting and theater production in the auditorium during fourth hour. Alex stated she went straight to the cafeteria through the two doors from the auditorium during that time.

Alex stated she entered the cafeteria at 1115 or 1116 hours. She stated the lunch line was short and she ment straight to a serving line to buy food. She indicated her path through the cafeteria on the attached diagram and indicated which table she sat at. The table is number "Z". Alex stated she did not notice any large duffle bags in the cafeteria. She stated three to five minutes after she sat down the commotion began. She stated what caught her attention was the noise level in the cafeteria rose. She stated people began to move slowly at first, to get a better look at what was going on outside. She stated that everyone was looking out the west window. Alex stated she looked out and saw an unknown boy run and she noticed he had blood on his jeans. She then heard popping sounds and knew that it was gunfire. At first she thought the blood might be faked because she had worked with stage blood before.

Alex stated she saw DYLAN KLEBOLD's back as he walked north bound up the small hill on the grass. She stated she recognized him because of his dark colored duster, his dark hat, and his hair. She stated he was out of sight for just a few seconds and then he walked back down the hill. She stated she hesitated and watched because she wanted to make sure that it was him. She stated she did this partly out of disbelief and then she wanted to identify him.

Alex stated when he came back into her line of sight he no longer had a shotgun that she could see him carrying when he was walking away from her. She stated when he was walking back down the hill, he now carried a gray metallic canister that she thought to be the size of a tear gas canister. She stated she watched him throw

it into the senior parking lot where it exploded.

Alex stated she ran to the north east corner of the cafeteria to get out of the line of sight from DYLAN KLEBOLD. Alex stated that she quickly looked into the cafeteria, looking to see if KLEBOLD was there or if perhaps ERIC HARRIS was in the kitchen. She stated she did this because KLEBOLD and HARRIS were always together. She did not see anyone in the kitchen. She then heard Mr. Andres, Jr. say "Alex, get in here". Mr. Andres was holding the auditorium door open. She stated people were screaming and were panicking at this time. She stated that she didn't feel as panicky as the others, she felt more in control and that she was not going to let herself panic.

At this time the fire alarm went off. She went through the auditorium up to the upper north entrance. She looked out to the left and saw that there was an open path. I asked if the security gate was closed at this time and she said that it was not. She turned to the right or east and continued in the hallway. She stated she left out of building near the counselor's office and the gym. She stated that she was running with about fifteen or twenty other people and they went to the smoker's pit. She stated she did not yell at anyone and does not remember anyone yelling at her. (See Control #1513, interview with Sarah Brown. Brown states Alex said something like, "Shut up, man, if I could I'd kill that girl" when Brown yelled at Alex to run.) She stated she was at the smoker's pit briefly and then went over the fence with the help of Zak Heckler.

Alex stated she had a dark green backpack with a strap on the top attached on one side for a handle. She had a black binder, an acting and theater production file folder, a burgundy leather covered book, a Celtic magic book, another book with a partial title of "Winds of ? ?", she could not remember, and a T-83 calculator. She stated she might have left a dark green binder sitting on top of the table. Alex was wearing black jeans and dark olive shirt with a Dolphins baseball cap and black boots.

Alex stated that she had seen KLEBOLD at the prom and she sat at the same table as he did. She stated that after the prom, DYLAN and HARRIS were smiling and having fun and gave no indication of their plans or problems they were having. Alex stated through the grapevine she heard that KLEBOLD and HARRIS had gone "paint balling" and that they had exploded a bomb somewhere at sometime.

Alex stated that sometimes they would get together with the group and talk about tactically how to blow up a room. She stated they did it more in a jokingly manner. They even talked about how you would go about

killing someone if you wanted. Again, she stated that it was all in a jokingly manner. She stated that none of the group liked "jocks" because they had a superior air about them. She further explained that they all thought it was funny how jocks play a child's game. She stated she never heard any of the group say any racist slurs. Then she added, "And if I ever did..." and her eyes widened and she raised her eyebrows (She is Hispanic). She stated she was never afraid of anyone in the group. Alex stated she never heard anything about the Internet use or a web site. She did know that ERIC HARRIS' nickname was "Reb".

Alex could not remember exactly what the thought for the day was but she did remember that it was a very long thought. She didn't think that it was anything bad. She stated Eric Veik does the thought for the day

Alex stated that the TCM group was dead this year, she described the group as being tame last year, and the year before that they were more alive, which she further described as bad. She stated that she was completely clueless and baffled about the shooting that KLEBOLD and HARRIS did. She suggested that I talk with Zak kler if I wanted to get an idea about how completely surprised people were at this. She stated Zak worked with KLEBOLD in the sound room during a play, "Smoke in the Room". She stated that even as close as Zak was to working with KLEBOLD, Zak was really surprised at this also.

ASSIGNMENT SYNOPSIS:

While interviewing Jessica Ann RUSCH at her home, Jessica stated her boyfriend, Patrick MCDUFFEE, was a member of the TRENCH COAT MAFIA. Patrick MCDUFFEE was present during RUSCH'S interview. MCDUFFEE sat back and offered no information until investigators prompted him.

Patrick MCDUFFY stated he was in the original TRENCH COAT MAFIA with Robert PERRY, Joe STAIR, and Chris MORRIS. MCDUFFY stated he recognized one of the shooters as by the description given by RUSCH. He stated he felt there were 4 or 5 people involved in the shooting. He stated the TCM often "Joked" about bombing and shooting up the school, but nothing serious.

MCDUFFEE stated KLEYBOLD and HARRIS were both very smart and capable of this destruction. He stated he did not know they were going to bomb the school. MCDUFFEE stated KLEYBOLD and HARRIS did some "Playful" videotaping using manikins. He stated the movie was like "Rambo" and it was filmed at their homes and edited at school. MCDUFFEE asked the Reporting Agent if we had seen the hand written note from HARRIS describing their journey. He stated KLEYBOLD and HARRIS had a computer site listing the 10 things they did not like. MCDUFFEE also provided the following nicknames; Chris MORRIS was GRUNT, Dylan KLEYBOLD was VODKA, and Eric HARRIS was REB. He stated Kristen THEOBOLD and Rebecca NELSON were also associates of the TCM. MCDUFFEE were the only two and was most likely capable of making bombs, and he thought

the bomb maker. MCDUFFEE stated Dylan KLEYBOLD bought a shotgun on his eighteenth birthday. MCDUFFEE stated that was all he knew about the TCM.

A follow-up interview with Patrick MCDUFFEE is recommended to clarify his knowledge of the TCM, its members, and his location when the shooting occurred.

Jerry W. Means, Agent-Colorado Bureau of Investigation

Patrick McDuffee, Dob: 05/03/81, was interviewed at his home, 6250 South Kendall Street, Littleton, Colorado by Investigator Thomas Wilson and Agent Frank Vanecek, Colorado Bureau of Investigation. After being adivised of the interviewing agents identity, McDuffee provided the following information:

McDuffee completed his graduation requirements in December 1998 and graduated from Columbine High School. McDuffee listed his associates as Chris Morris, Eric Harris, Dylon Klebold, Charles Phillips, Joe Stair, and Eric Dutro. His oldest association was with Charles Phillips. This association began in 1995 when McDuffee was a freshman. McDuffee had German class with Harris the last semester of 1998 and Composition with Klebold. McDuffee stated he started associating with Harris and Klebold in the Spring of 1997.

McDuffee stated that Joe Stair was the first person to wear a duster to school. Stair wore the duster because it was warm and dry while smoking outside the school. Other members of the group began wearing the oiled leather dusters and soon obtained the label "Trench Coat Mafia".

McDuffee stated that the groups common interests were as follows:

Music- Ramstein, KMFTM
Computers- Strategic Games, Command and Conquer, Dune,
Warcraft

Movies-Reservoir Dogs, Pulp Fiction, Replacement Killers

McDuffee communicated with the group through America On-Line (AOL) using the name ROMEO. He stated Eric Harris was REB and Chris Morris was GRUNT. Dylon Klebold did not have AOL, but used the computer name VODKA.

McDuffee took German as an elective class his last semester and the year before. He was active in school activities. He stated Eric and Dylon were active in the stage operations for school plays. Eric and Dylon allegedly controlled the stage lights.

McDuffee became part of the Trench Coat Mafia (TCM) in May 1997. At that time Dylon was wearing RAMSTEIN and KMFTM t-shirts. McDuffee wore a duster which he got from Chris Morris. Other students continued to call them TCM and they adopted the title.

Two members of the TCM, Chris Morris and Robert Perry, would fight a lot among themselves, but not with other students.

"Chuck" was identified as Charles Phillips.

McDuffee was in the Chess Club with Dylon Klebold.

Chris Morris did not like "Jocks". Most problems were with the football players from the previous year.

Eric Harris did not like black people.

McDuffee thought and would be the ones to commit such a violent act. He suspected them until suspect identification was made.

Dylon attended the prom with Robyn Anderson.


McDuffee did not think Harris or Klebold possessed weapons, but stated Charles Phillips and John Beachum may have had weapons. In 1996 or 1997 McDuffee was in a car with kids from Chatfield High School when they went to a field and detonated three pipe bombs under tree stumps. There was a total of fifteen kids in three cars. Chris Morris and Charles Phillips were the only two he knew by name. The Chatfield High School guys had six inch pipe bombs, made of PVC pipe, which they placed in holes under the stumps.

Everyone has a copy of the Anarchist Cookbook, which is downloaded from the Internet.

Dylon has an ASP (baton) which he carried in his car. The ASP was purchased at a security store in Southwest Plaza mall.

Dylon purchased a shotgun on his eighteenth birthday, either from a K-Mart or Walmart. There had been loose talk in the group about someone owning an Uzi. This talk was circulating in late 1997. The group used to discuss guns such as the AK-47 and MP-5.

When asked about who in the group could plan the attack, McDuffee provided the following names:



When asked about videos made by the group, McDuffee stated a video was made as a joke against the jocks. There was a dummy made out of pillows, dressed in football gear, which was then assaulted by the group.

When asked about drug use, McDuffee stated Harris and Klebold smoked marijuana, but used no other substances.

McDuffee felt Klebold and Harris could have manufactured the bombs in three days.

Sometimes Klebold and Harris wore Soviet lapel pins.

McDuffee stated he stopped wearing the dusters last semester, 1998.

McDuffee was home the day of the shootings and was not able to provide any information concerning the scene.

On 042899 Patrick McDuffee was re-contacted by Inv Thomas Wilson and Inv Don Estep at 6250 South Kendall Street, Littleton, Colorado. McDuffee was re-interviewed concerning statements made to Jefferson County Deputy Warren on 042099 at 2130 hours. McDuffee was asked to explain statements referenced in Deputy Warrens report and provided the following responses:

On 042099 McDuffee was working in Elizabeth, Colorado. He was installing windows for his employer, only known as Curt. He finished work at about 1830 hours and responded to the area of Leawood Elementary School to see what was happening with the shooting incident.

Report indicated the helped with the planning of the attack. McDuffee stated this was speculation on his part and he only meant the possible had helped.

Report indicated Dylon Klebold was at the school, had a hand gun, baton, knife, and built bombs like pipe bombs and cocktail bombs. McDuffee did not see Klebold at the school, but knew he had a hand gun and a baton. He had only heard that Klebold built bombs.

Report indicated was at the school, by the library, with a gun, and he has many types of guns. McDuffee stated he had seen and during the evening. Was wearing a white football jersey with the word Columbine across the chest. This was unusual as the bever played football and had not been at the school for two years. The had talked about having a street sweeper shotgun in 1997-98. Mcduffee indicated it was a shotgun with the barrel sawed off and flattened.

Report indicated with small PVC pipe bombs that detonated in his back yard, destroying trash cans. The statement about the behalf bombs for the attack was speculation.

Report indicated and the helped build bombs and tested them with Phillips. McDuffee claimed he did not tell the Deputy that and has no knowledge of the claimed activities.

Report indicated "LNU) was part of the planning, stored the weapons, and transported the weapons to the school. McDuffee stated drives around and possibly stored weapons in his white bronco because of the space in the back. He has no knowledge that this actually occurred.

Report indicated Eric Harris had many different types of guns and made the statement "I will kill jocks and blow up a school". McDuffee stated he only knew about Harris owning a handgun, but Harris liked to own guns because it was his right. Harris did state he wanted to kill jocks and blow up the school, but these statements were made during bowling throughout the year, when everyone joked about doing the same thing.

Report indicated was inside the school during the attack, wrote letters, and made violent videos. McDuffee stated was not observed. Report indicated was part of the planning. McDuffee stated this was speculation.

Report indicated was at the school with an automatic gun, downstairs by the door, shooting outside. McDuffee stated that he was told by Brenton Hooker that was in the school, by the double doors to the cafeteria. Was identified only by his build as the subject was wearing a mask. The subject, was on the East side of the cafeteria and fired at Hooker as Hooker tried to enter the school from the West to rescue his girlfriend, Sarah (LNU). McDuffee was told by his

girifriend, Jessie Rusch, that the suspect who attempted to enter the science room looked like that was also wearing a mask.

McDuffee was asked, in the presence of his parents, to provide his computer for examination. He was also asked for consent to acquire AOL records. McDuffee, after obtaining consent from his parents, provided Investigator Estep with his CREATIVE 486 CPU, serial number C094050166. The computer was placed in evidence at JCSO. The AOL consent form was completed and indicated McDuffee used his fathers account, Eric Peth/(RPETH), screen names ROMEO23718 and EXTREME290, passwords PIMP4U and 1QAZ.

Chris Morris time line for April 20, 1999.

Between 6:00 a.m. and 7:20 a.m. Chris has a first period bowling class at Belleview Lanes located at South Federal Blvd., and West Belleview Ave.

After Bowling class Chris goes to McDonalds for breakfast than drives to Clement park. At 8:10 a.m. Chris is at Columbine High School for his second hour class. Between 8:20 a.m. and 9:20 a.m. Chris attends his Science class taught by Mr. Friesen.

Between 9:25 a.m. and 10:15 a.m. Chris attends his third period Government/Economics class taught by Mr. Tonelli.

Chris did not attend his fourth period Acting class and left Columbine High School at 10:20 a.m. This information was verified by several witness who reported seeing Chris drive from the school in a red compact car. Chris was described as wearing a dark colored beret and sun glasses. Between 10:30 a.m. and 10:45 a.m. Chris arrives at Corey Friesen's home which is located just west of South West Plaza. Between 11:30 a.m. and 11:35 a.m. Ms. Friesen contacts Corey at their residence by telephone and advises him of the shooting at Columbine High School. Corey tells his mother that he is with Chris Morris and he has not heard from his father Kenneth Friesen.

At 11:45 a.m. Chris calls the Jefferson County Sheriff's Office and speaks with Investigator Tom Acierno. Chris is calling from the Friesen's home.

At 12:30 p.m. Chris and Corey drove to Chris's girlfriends to check on her welfare they than drive back to the Friesen's home. Once they returned to the Friesen's a concerned neighbor contacts Corey and Chris. Chris eventually calls his mother who works for the Cherry Hills Police Department and subsequently talks to a detective.

At 2:08 p.m. Chris calls the Jefferson County Sheriff's Office and is subsequently picked up at the Friesen's home by Deputies from the Sheriff's Office and is interviewed.

Information obtained for this time line has been confirmed through witness statements.
