L-3 Selected to Build Additional Helicopter Cabin Assemblies for Bell UH-1Y

CRESTVIEW, Fla., September 13, 2010 – L-3 Platform Integration Crestview Aerospace has been selected by Bell Helicopter, a Textron Inc. company, to produce 38 UH-1Y cabin assemblies. The contract calls for L-3 Crestview Aerospace to deliver the cabin assemblies between 2010 and 2013.

“Continuing our relationship with Bell Helicopter is important to our team,” said Barry Steiner, president of L-3 Crestview Aerospace. “We look forward to extending our record of on-time, on-budget cabin assembly deliveries.”

Under a preceding contract, L-3 Crestview Aerospace has delivered 35 cabin assemblies to Bell, with five remaining to be produced.
