L-3 Platform Integration Delivers First Aircraft for Latest Navy P-3 Sustainment Program

WACO, Texas, November 1, 2012 – L-3 Platform Integration announced today that it has delivered its first P-3 aircraft under the latest U.S. Navy Sustainment, Modification and Installation Program (SMIP).

Under the SMIP awarded in 2011, L-3 is the sole commercial provider of aircraft sustainment services for the U.S. Navy's fleet of P-3, EP-3 and NP-3 aircraft. The indefinite-delivery, indefinite-quantity (ID/IQ) program is a follow-on to a similar contract awarded to L-3 in 2005.

"Our team is proud to deliver this first aircraft 45 percent faster than the average delivery time of our first SMIP contract," said Nick Farah, executive vice president of L-3 Platform Systems, which includes L-3 Platform Integration. "We are committed to continuous improvement, and we know that accelerating the turnaround time in such a dramatic way reduces the cost of sustainment and increases the operational availability of the aircraft to the warfighter."

The SMIP provides for an intensive depot-level process for P-3 airframe and component inspection, repair and replacement. The program corrects deficiencies to ensure safe and reliable operation, as well as to enhance aircraft service life to sustain inventory levels for operational requirements.

Work under SMIP is performed on all types, models and series of P-3 aircraft in the 147-aircraft U.S. Navy fleet.

L-3's SMIP work includes a range of aircraft sustainment and modernization activities, including P-3 outer wing refurbishment, P-3 outer wing installation, special structural inspection kits (SSI-Ks), phased maintenance inspections (PMIs) and modification/installation programs (MIPs).

L-3 Platform Integration in Waco, Texas, provides complex aircraft integration, sustainment and modification services for military, commercial and OEM customers.
