### **L-3 Integrated Optical Systems Selected by the NSATC/JSSAP for the Small Arms Weapons & Fire Control (SAW&FC) Demonstration Initiative**

PITTSBURGH, August 13, 2012 – L-3 Integrated Optical Systems announced today that it has been selected by the National Small Arms Technology Consortium (NSATC)/Joint Service Small Arms Program (JSSAP) Office for the Small Arms Weapons & Fire Control (SAW&FC) Demonstration Initiative. Under SAW&FC, precision components will be developed to assist the warfighter in obtaining an accurate range to the target, enabling effective engagement of a stationary or moving target.

For its part, L-3 Integrated Optical Systems will demonstrate a fully integrated SAW&FC prototype that provides multi-spectrum imaging, multiple target tracking and beam-steering laser rangefinding (LRF).
