L-3 INTEGRATED SYSTEMS AND TOBYHANNA ARMY DEPOT SIGN TEAMING AGREEMENT

NEW YORK, NY, February 1, 2007 – L-3 Communications (NYSE: LLL) announced today that its Integrated Systems (L-3 IS) subsidiary and Tobyhanna Army Depot in Pennsylvania have signed a Teaming Agreement (TA). In the event that L-3 wins the Joint Cargo Aircraft (JCA) Program, the agreement will serve as the basis for a long-term, strategic partnership between Tobyhanna and L-3 IS for JCA logistics support requirements and future aircraft support opportunities.

“L-3 is proud to team with Tobyhanna on the C-27J Spartan offering for the JCA program,” said Bob Drewes, President and Chief Operating Officer of L-3 Integrated Systems Group. “This agreement is the beginning of a public-private partnership relationship that will bear fruit in the form of better support to the ‘last tactical mile’ of the Global War on Terror and better stewardship of taxpayer dollars.”

Each party to the agreement brings complementary capabilities and objectives to the relationship. L-3 IS seeks to provide high-quality, cost-effective logistics and engineering solutions for the JCA throughout its lifecycle.
