SUPPLIER ROUTING INSTRUCTIONS TO BRISTOL FROM WITHIN THE UNITED STATES.

General

These routing instructions are to be followed when shipping to L-3 Communications Telemetry-East (TE) facility located in Bristol, Pennsylvania, USA from locations within the United States. These instructions apply for all shipments unless an L-3 TE purchasing agent has agreed to other shipping arrangements in writing.

- **L-3 TE Communications reserves the right to debit supplier's account for all costs incurred through supplier's non-compliance with these instructions.**

Shipment Terms

- All shipments are to be shipped origin freight collect.
- No Prepaid and Added freight charges of any kind will be paid or allowed by L-3 TE on supplier invoice.

Information required on Shipping Documents

L-3 TE purchase order number must appear on all shipping documents including, but not limited to, bill of lading, airbills and all address labels. If no purchase order is available, the name of an individual or department to whom the shipment is to be received must be indicated on the shipping documents.

Marking of Packages/Shipping Containers

Each package/shipping container must be marked/labeled to include the following:

- L-3 TE purchase order number(s). If no purchase order is available, the name of an individual or department to whom the shipment is to be received must be indicated on the shipping label.
- Supplier's and consignee's complete address.

Insurance

L-3 TE is self-insured. Do not insure or declare a value for carrier insurance regardless of Mode of transportation unless specifically requested by an L-3 TE employee. Charges billed by carrier for insurance will be debited from supplier's invoice.

Restricted Articles

Shipments containing hazardous material must be in compliance with all Federal, State and Local laws and regulations (including carrier's rules) governing the packaging, labeling and preparation of shipping documents. Material Safety Data Sheets must be with shipment.

Carrier Routing

Supplier is to call designated carrier(s) local terminal or toll free number to arrange for freight pick-up at supplier's dock.

SURFACE ROUTINGS

- 0 to 150 lbs Ship UPS Ground Service collect using account number 177699.
- Over 150 lbs shipments Pilot Air Freight.

AIR ROUTINGS

- Same day shipments can only be made by contacting the Traffic Supervisor At (267) 545-7127.
- Next day air shipments weighing 1 to 150 lbs. Can be sent via Fed-Ex.
- Second day air shipments weighing 1 to 150 lbs. Can be sent via Fed-Ex Second Day Air.

All inbound Fed-Ex shipments should reference account number 0191-2597-1 Collect shipping charges.
