L-3 COMMUNICATIONS RECEIVES CONTRACT AWARD FOR THE KG-3X CRYPTOGRAPHIC MODERNIZATION PROGRAM --L-3 Communications Supports Government's Security Upgrades--

NEW YORK, NY, July 29, 2004 -- L-3 Communications (NYSE: LLL) announced today that its Communication Systems-East (L-3 CS-East) division has been awarded a contract by the U.S. Air Force for the initial System Development and Demonstration (SDD) Phase I of the KG-3X Cryptographic Modernization Initiative (CMI) program. L-3 CS-East was one of two winners of firm fixed price contract awards, each valued at \$13.5 million. The Headquarters Electronic Systems Center, Hanscom Air Force Base, Mass., will manage the contracting activity for the U.S. Air Force.

The SDD Phase I is scheduled to be completed by June 2005. After completion of SDD Phase I, one winner will be selected for the remainder of the program, which will include the completion of the SDD, Low Rate Initial Production (LRIP), and Production/Deployment.

The Multi-Phase KG-3X program will modernize the legacy cryptographic units used in the U.S. government's Minimum Essential Emergency Communications Network and the Fixed Submarine Broadcast System used for transmission of emergency action messages for nuclear and national command and control of U.S. strategic forces. The KG-3X program includes the design and integration of these cryptographic units with their associated legacy receivers and transmitters onto the E-4B, E-6B, and B-52H aircraft, and into the Broadcast Key Sites, as well as the upgrade of associated trainers and system

integration laboratories and support facilities. L-3 Communications Integrated Systems (L-3 IS) division is teamed with L-3 CS-East to develop installation designs and perform platform integration.

This SDD Phase I award further strengthens L-3 CS-East's position in supplying the U.S. Government with secure communication capabilities with its existing portfolio of secure voice, data, key management, embedded solutions and IP network encryption. L-3 CS-East is a leading supplier and developer of Type 1 secure solutions that support the government's overall CMI. L-3 IS brings integration expertise and experience with many of the aircraft to be upgraded during the KG-3X Program.
