L-3 COMMUNICATIONS TO PRODUCE SECURE VOICE OVER INTERNET PROTOCOL COMMUNICATION SYSTEMS USING CISCO TECHNOLOGY -- Supports Government's Global Information Grid Initiative --

NEW YORK, NY, June 1, 2005 - L-3 Communications (NYSE: LLL) announced today that its Communication Systems-East division, a leading supplier of secure government communication products and systems, has reached agreement with Cisco Systems, Inc. to utilize Cisco voice technology in L-3's secure Voice Over Internet Protocol (VoIP) voice endpoints for use by U.S. Military and Government organizations.

As a result of this agreement, L-3 will offer an IP-enabled Secure Terminal Equipment (IP STE), a system based on the widely used L-3 STE and Cisco's IP Telephony technology. The IP STE, once certified by the U.S. Government, will support classification levels up to Top Secret. The IP STE will facilitate the convergence of voice and data communications onto a single data network supporting the Department of Defense's Global Information Grid and other secure VoIP applications.

Currently over 120,000 STE terminals are in use worldwide providing secure communications. The VoIP capability can be implemented into standard STEs through an upgrade kit which incorporates the Cisco network interface and certain IP software.

"We are delighted to work with Cisco in the development of the IP STE. This effort takes advantage of L-3 Communication Systems-East's 55-year history of providing high assurance communication security (COMSEC) products to the U.S. Government and Cisco's unmatched record of network technology

innovation to offer the government a much anticipated capability, secure IP-based voice communications,” said Gregory B. Roberts, president of L-3 Communication Systems-East.

This agreement further strengthens L-3 Communication Systems-East’s position in supplying the U.S. Government with secure communication capabilities. L-3 Communication Systems-East, based in Camden, NJ, is a leading supplier and developer of Type 1 secure solutions with a broad portfolio of secure voice, data and encryption products as well as critical enabling technologies including key management and embedded encryption.
