L-3 Installs Interoperable Communications System in Burlington County State-of-the-Art Emergency Operations Center --MarCom® System Tested and Fully Operational--

CAMDEN, N.J., December 2, 2008 – L-3 Communication Systems-East has completed the installation and testing of their MarCom® Interoperable Communications System in Burlington County, N.J.'s Emergency Operation Center (EOC).

The MarCom system gives operators and responders the ability to communicate with various agencies, despite the many differences in radios, frequencies or PBX systems. L-3 has applied this application to solve the interoperable communications challenges encountered at Emergency Operations Centers around the country. The Burlington County EOC is a national model test site for this specific application.

L-3's one rack system houses equipment which provides the backbone for interoperable communications. The system has been extensively tested and is now fully operational. The L-3 MarCom Compact Integrated Voice System (CIVCS) supports telephone switch board connection, regular telephones and analog connections to radios.

Burlington County EOC and L-3 Communications will be holding an Open House for Emergency Response Stakeholders including 911 coordinators, police, fire, state and county government representatives at the Westampton, N.J. site to include product demonstrations on Tuesday, December 9, 2008 from 10 a.m. to 3 p.m.
