GRIEVOUS MENTAL SUFFERING

LIBEL FOR DIVORCE

TO THE HONORABLE THE PRESIDING JUDGE OF THE ABOVE ENTITLED COURT:

Comes now STANLEY ANN D. OBAMA, Libellant above named, and complaining of BARACK H. OBAMA, Libellee above named, respectfully show as follows:

I

That Libellant is now and for more than two years past has been a resident of Honolulu, City and County of Honolulu, State of Hawaii; that Libellee is residing at 170 Magazine Street, Cambridge, Massachusetts.

II

That Libellant and Libellee were lawfully married in Wailuku, Maui, State of Hawaii, on February 2, 1961, by a person duly authorized to perform marriage ceremonies and ever since that date have been and are now husband and wife.

III

That Libellant and Libellee last lived together as

husband and wife in Honolulu, Hawaii, but said parties are now living apart.

IV

That one child has been born to said Libellant and Libellee as issue of said marriage, to wit: BARACK HUSSEIN OBAMA, II, a son, born August 4, 1961.

V

That Libellee has been guilty, whether intentionally, studiedly, wilfully, deliberately, or not, of inflicting such grievous mental suffering upon the Libellant, continued over a course of not less than sixty (60) days as to render the life of the Libellant burdensome and intolerable and the further living together of Libellant and Libellee insupportable.

WHEREFORE, Libellant prays:

1. That process of this Honorable Court issue in such manner as is provided by law summoning said Libellee to appear and answer this libel;
2. That Libellant be granted an absolute divorce from said Libellee;
3. That the sole care and custody of the above named minor child be awarded to Libellant;
4. And for such other and further relief as to this Court may seem just and proper in the premises.

## Decree of Divorce

On this 5th day of March A.D. 19 64 at the Court House in the City of Honolulu, openly in the Public Court Room of said Judge, came on duly to be heard the petition of said above named Libellant, of the City and County of Honolulu, State of Hawaii, praying that the bonds of matrimony heretofore existing between them, the said LIBELLANT and LIBELLE be dissolved by reason of the alleged grievous mental suffering inflicted upon Libellant by Libellee;  
And the said Libellant and her attorney, GEORGE L. T. KERR, being present in Court before said Judge, due proof was made to this Court that the said parties are legally intermarried, and that the allegations in said petition are true.

It is hereby Ordered, Adjudged and Decreed, That the bonds of matrimony existing between the said LIBELLANT and LIBELLE be and the same are hereby dissolved. This decree to take effect from and after the date of signing and filing hereof.

IT IS FURTHER HEREBY ORDERED, ADJUDGED AND DECREED that the Libellant be and she is hereby granted the care, custody and control of BARACK HUSSEIN OBAMA, II, the minor child of the parties hereto, with the right of reasonable visitation in the Libellee, and further that the question of child support is specifically reserved until raised hereafter by Libellant.
